BOARD OF DIRECTORS MEETING MINUTES
August 5, 2020

The Board of Directors met at Kozmo's Grille on Tuesday, July 7, 2020. The following members were present: Keith Nutter, Joe Logan, Bill Leffler, Matt Hull, Richard Regula, Todd Loxley, Chad Hartman, and Richard Leffler.

The first matter of business was to approve the minutes of the July 7, 2020 meeting. Upon motion duly made, seconded and unanimously carried the minutes of the July 7, 2020 meeting were approved.

SECRETARY'S REPORT:

Mr. Hull presented to the Board the resignation submitted by Linda Litman. Upon motion duly made, seconded and unanimously carried the Board accepted her resignation as a member of the Rotary Club of Massillon with regret. Mr. Hull next presented to the Board the proposal to add Todd Loxley as a member of the Board of Directors. Upon motion duly made, seconded and unanimously carried the Board voted to add Mr. Loxley as a member.

TREASURER'S REPORT:

Mr. Leffler indicated that the quarterly bills would be sent out soon, adjusted for the meals that were missed while the Club did not meet due to COVID-19. Mr. Leffler also discussed setting a date and time to review the proposed Club operating budget for 2020-2021. Once determined, this date and time will be sent to all Board members to participate in the discussion of the budget with Mr. Leffler and Mr. Hull.

CLUB SERVICE:

Mr. Hartman discussed the temporary suspension of the Club's delivery of meals for Meals on Wheels due to COVID-19. Mr. Hartman indicated too many meal recipients were not following the recommended safe delivery guidelines as laid out by Meals on Wheels. We will continue to assess this situation and return to delivering meals when our members feel safe to do so. It was also noted that Michelle Hartman will be taking over for Chad Hartman as the Club Service Chair due to the fact that Mr. Hartman is also the Club's President-Elect.

MASSILLON ROTARY FOUNDATION:

Mr. Logan stated that there was no new business to report since the Board's last meeting in July.

INTERNATIONAL:

Mr. Leffler stated that there was no new business to report since the Board's last meeting in July.

PROGRAMS:

The Board discussed the return of regular weekly lunch meetings at the Eagles. The Board further discussed the necessity to stress to Club members not to come to the weekly meetings if they are feeling ill or showing symptoms of COVID-19. Mr. Hartman gave an update on the upcoming programs and noted that it has been somewhat difficult to get speakers lined up due to COVID-19. Mr. Hartman asked that if anyone has a contact that would like to be the featured speaker one week to please let him know.

OLD BUSINESS:

The Board discussed the status of the Rotary Pavilion Project of which Mrs. Litman had been keeping the Board apprised. Mr. Hull stated he would follow up with Mrs. Litman to see if she would still like to be involved in that project. The Board discussed the Paul Brown Scholarship and the scholarship committee and the desire to hold an annual event for the recognition of the scholarship award as has been done in prior years. The scholarship committee will need to meet and set a direction for the upcoming year.

NEW BUSINESS:

Open positions for members of the Board was discussed with recent members resigning from the Club or reaching their term limit on the Board. Additional efforts will be made to replace open Board positions with current Club members. A suggestion was made to reach out to Dan Swartz to see if he would like to join the Board. Mr. Hull stated he would follow up with Mr. Swartz.

The next regularly scheduled meeting on the Board of Directors is Tuesday, September 1st, at 11:30am, at Kozmo's Grille.
