Rotary Membership Application

The Rotary Club of Steubenville offers several different Membership Levels and Participation.

Corporate Membership – Includes full membership for one key individual who represents the company in Rotary International and the Rotary Club of Steubenville and includes all voting privileges. This level of membership also includes two Associate Memberships.

Individual Club Membership – Includes for membership for one individual in Rotary International and the Rotary Club of Steubenville that includes all voting privileges.

Associate Membership—includes membership for one individual in the Rotary Club of Steubenville. At any time, this individual can move to an Individual Membership or Corporate Membership.

Annual dues are assessed for all members based on their Level of Membership. Dues may include Rotary International, District Dues, Local Club Dues, Steubenville Rotary Foundation and The Rotary International Foundation Assessments and Lunch or other meal costs.

Upon receiving your application, the Club Membership Committee will review and submit to the Board of Directors for approval. After Board approval all members will be notified of your pending application. Installation will occur at a regularly scheduled meeting with orientation offered on a quarterly basis. A mentor will also be assigned to guide you on your way to a fulfilling Rotary life. You will be invoiced after installation. You may be invoiced quarterly or yearly.
