What do my dues cover?

Annual club dues:

Administrative costs of the club (bookkeeping, tax preparation, banking fees, postage, storage unit rental, website maintenance) and costs associated with club leader training (the club covers costs for mandatory trainings for the president-elect and for the president-elect to attend the annual Rotary International convention) and membership development (e.g., guest lunches, new member education sessions). *Members 40-years-old and younger and second family members (e.g., spouse, child) are eligible for a dues reduction of \$150.

Rotary International Dues

A subscription to the *Rotarian* magazine and expenses associated with support for clubs, securing insurance policies for clubs, development of learning materials, and administrative expenses (e.g., staff, website maintenance, accounting). Note that these dues will increase slightly (~\$5/year) over the next three years.

Rotary District 5340 Dues

Costs to host District seminars and trainings as well as administrative costs.

Why are there suggested donations?

- The Rotary Club of Del Mar Foundation is a 501(c)3 organization that provides funding for club projects, especially those that arise with little notice (e.g., supporting Ukrainian refugees, making repairs at organizations we support). A robust endowment allows us to say "yes" to more projects.
- The Rotary International Foundation is critical to support projects at international (our club is known for our international projects) and local levels. Donations we make now are invested and then returned to our club as District Dedicated Funds that we use to extend our impact. Donations to both foundations are tax-deductible.

Why are optional items?

- Members are encouraged to attend the holiday and demotion parties, but are billed only if they sign up to attend.
- Costs for lunches are paid directly to Pacifica Del Mar. Members are always free not to eat lunch.
- Auction items (e.g. gift cards, gift baskets, wine, trips) or a cash donation is strongly encouraged to support the Sunset Soirée, our annual fundraiser that provides funds to fuel the majority of club projects.
