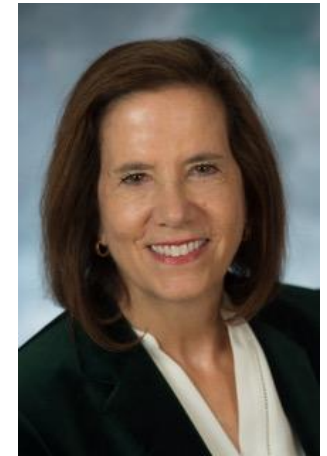

BARBARA NOTAR IS AN ATTORNEY WHO BEGAN PRACTICING LAW PRIOR TO THE USE OF EMAIL. SHE BEGAN HER CAREER AS A CRIMINAL DEFENSE LAWYER IN BOSTON, MASSACHUSETTS. SHE STEPPED AWAY BEFORE HER SECOND CHILD WAS BORN AND RE-ENTERED THE PRACTICE OF LAW 14 YEARS LATER IN 2008 WHEN SHE WAS HIRED AS THE DEPUTY TOWN ATTORNEY FOR THE TOWN OF LEESBURG. SHE WAS PROMOTED TO TOWN ATTORNEY IN 2015, LEFT THE TOWN A FEW WEEKS PRIOR TO THE PANDEMIC AND JOINED A CIVIL DEFENSE FIRM IN FAIRFAX COUNTY DEFENDING LOCAL GOVERNMENTS AND THEIR EMPLOYEES. FOR THE PAST 2 YEARS, SHE HAS WORKED IN THE LOUDOUN COUNTY ATTORNEYS' OFFICE. SHE AND ANOTHER LAWYER ARE ASSIGNED TO REPRESENT CHILD PROTECTIVE SERVICES AND ADULT PROTECTIVE SERVICES. BARBARA ALSO REPRESENTS THE LOUDOUN COUNTY DEPARTMENT OF MENTAL HEALTH, SUBSTANCE ABUSE AND DEVELOPMENTAL SERVICES.

WHEN SHE WASN'T PRACTICING LAW, BARBARA WAS HEAVILY INVOLVED IN THE NONPROFIT SECTOR OF LOUDOUN COUNTY. SHE IS THE FORMER PRESIDENT OF LOUDOUN INTERFAITH RELIEF, NOW LOUDOUN HUNGER RELIEF; THE FOUNDER AND FORMER PRESIDENT OF SAVE THE TRAIL WHICH SUCCESSFULLY PREVENTED DOMINION VIRGINIA POWER FROM CONSTRUCTING OVERHEAD TRANSMISSION LINES ON THE W&OD TRAIL; AND WAS THE EXECUTIVE DIRECTOR OF THE LOUDOUN LITERACY COUNCIL.

BARBARA LIVES IN CHESTERFIELD PLACE IN DOWNTOWN LEESBURG. SHE HAS 2 CHILDREN: LAUREN WHO IS 30 AND WHO LIVES IN DENVER, CO, AND JACK WHO IS ALMOST 29 AND LIVES IN SAN DIEGO, CA.
