Social Media and Rotary Jul 05, 2011

Many Rotarians already use Facebook, text rather than call, and perhaps are on Linked In or have a Twitter account, especially our younger members. Most of us have children and grandchildren who use these forms of social media. Companies and organizations are also starting to use social media to help them market themselves and to communicate more rapidly with their customers. Did you know that our Club has a Facebook Account?

Social media is really a complement to other forms of communication, such as our website and advertising in newspapers and magazines. Traditional advertising like those just mentioned are consider "pull" type of communication, pulling the consumer in to consider our programs and services. Social Media, on the other hand, is a "push" type of advertising or communication. Through our Facebook account or Twitter, for example, we can push information out to our members and to others in the community.

Interestingly, people 55 years and older had the largest increase, over 900%, in the use of Facebook last year. Social Media, unlike traditional advertising or communications, is twenty-four hours a day, seven days a week, so it needs to be monitored closely like a small child and updated regularly. Your Club Director, Alan Schrope, is in charge of PR this year. He and his committee will be focusing on updating our Facebook page, and our website to communicate the good projects our Club does, what Rotary is all about, and to hopefully recruit new members. Notes: Dues are billed quarterly as \$285.00 and are not broken down into the above categories. The billing cycle occurs the first of July, October, January, and April. Attendance Exempt and Leave of Absence members, guests, and visitors are charged \$20.00 per meal except for special upgrades which are charged at \$25.00. Attendance Exempt and Leave of Absence member dues: \$102.50 per quarter or \$410 per year. Club Admission fee: \$300 (does not apply to Rotarians transferring from another club).
