Your Board also reviewed our need to enforce our policies on payment of quarterly dues. Anyone who has not brought their dues current within 180 days, will be terminated from our Club. Remember, we have to pay \$20 to the Doubletree for all members attending our lunch meetings and we also are required to pay our District and RI dues in advance based on our membership. It is only fair to require that all members pay their dues in a timely manner. If you have a special circumstance and need a brief payment plan to get caught up please call Patrick.

On a good note, last year's final financial report ended better than budget which helped to allow us to keep dues flat for this year. This is due to the good fiscal management of your Past President Marianne and the frugal excellence of our wonderful Executive Director, Mary, and to the oversight and control of your Treasurer, Patrick. The Board voted to have an outside financial review this year to add to the additional controls that we have put in place over the past two years. As you may recall, we have an outside firm who prepares our federal and state payroll taxes, our 990 IRS report, and our bank reconciliations.
