The Search for Hazardous Asteroids

The Catalina Sky Survey (CSS) is part of a NASA-supported program to inventory the largest asteroids that could be a threat to the Earth. With two telescopes in Arizona and one at Siding Spring, Australia, CSS has been operating since late 2004, and is the current discovery leader, finding about 70 percent of all new NEOs in each of the past five years.

Since 2002, Ed Beshore has been the operations manager for the Catalina Sky Survey, a leading NASA-funded program to inventory asteroids and comets that may represent a hazard to the Earth. Since April of 2009, he has been the principal investigator for the Catalina program. His interests include physical characterization of asteroids, scientific software development, robotic telescopes, survey techniques and technologies, large data set management, and high performance processing pipeline development. Before coming to the U of A, Beshore was a senior officer of a technical marketing company in Colorado Springs, and an R&D Project Manager for Hewlett-Packard. He has also worked as a software engineer at the MMT Observatory, the Boeing Company, and on the Pioneer 11 mission to Saturn. Beshore has his own observatory in Colorado. His other interests include travel photography and geology.

# Thank a Tucsotarian Sponsor - Ken Light (Tucson Jewish Community Center)

Club member KEN LIGHT is President and CEO of the Jewish Community Center. Ken has been a member since September 1991.

The Tucson Jewish Community Center is a not-for-profit social service institution that has been meeting the needs of Tucsonans since 1949. While we are a Jewish institution, we are not a religious organization, seeking instead to meet the needs of both the Jewish and general community with social, cultural, educational, and recreational services.

We begin with 6 week old infants in a childcare/preschool serving approximately 350 children under the age of 5, and continue with after school care, summer camp, services for adults, media arts, and arts and culture. We have a full-day program for young adults with special needs and a fully inclusive special needs component for children in preschool, after school and summer camp programs as well. Completing our array of services is a comprehensive sports and wellness department with over 100 classes/week and an equal number of teams involved in league play for kids and adults. The facilities provide programming in fitness, basketball, tennis, racquetball/squash, and aquatic areas with swim teams, lessons, and a Masters program as well. Rounding out the facilities is a splash park for kids, ball fields, and a newly established sculpture garden. Membership is open to all with scholarships available for those unable to afford the full cost of services. (Over \$550,000 annually is given away in financial assistance).

Membership rates vary by category and range from \$37/mo for a teen to \$61/mo for adult individual to \$103/mo for a Family. These rates are generally all-inclusive with the exception of child care or summer day camp or league/lesson fee.
