Guadalupe Ramirez began his government career in 1985 with the U.S. Border Patrol as a Border Patrol Agent in Eagle Pass, Texas. In 1987 he transferred to the U.S. Customs Service as a Customs Inspector at the Port of El Paso, Texas. In 1990 he was selected for a two year assignment as a Physical Techniques Instructor detailed to the Federal

Law Enforcement Training Center in Glynco, Georgia. Two years later he was promoted to Supervisory Customs Inspector/Instructor at the U. S. Customs Academy were he was responsible for developing and providing both basic and advance training to Customs Officers on the variety of agency specific functions.

In 1995, Mr. Ramirez was appointed to the Dallas Strategic Trade Center as an International Trade Specialist. In this capacity he conducted in-depth analysis of trade data and developed strategies designed to address non-compliance of U.S. Customs laws, rules and regulations.

In 1999, Mr. Ramirez was assigned to the Office of International Affairs as a Customs Advisor to the country of Trinidad and Tobago. As an advisor he worked directly with the Trinidad and Tobago Customs and Excise Division in the area of process improvement and automation of their processes. During this time he also worked closely with the US Embassy and the American Chamber of Commerce to assist U.S. companies interested in establishing business in Trinidad and Tobago.

In August 2001, Mr. Ramirez was selected as the Port Director of the Port of Santa Teresa, New Mexico. After the tragedies of September 11th, the Port of Santa Teresa experienced a 300% growth in traffic and narcotic interdiction. Mr. Ramirez was responsible for all port operations as well as directing the growth and expansion of the port.

In 2004, Mr. Ramirez returned to the Office of International Affairs as a Customs Advisor working directly with the Narcotics Affairs Section of the U.S. Embassy in Caracas, Venezuela. While in Venezuela, he directed the establishment of a container inspection facility in Puerto Cabello, the nation's largest seaport, which would be utilized by the Government of Venezuela to target and examine high-risk shipments being exported to the U.S. and other nations.

In 2006, Mr. Ramirez was selected as the Assistant Port Director for Passenger Operations at the Port of Laredo, Texas.

In 2009, Mr. Ramirez was selected as the Port Director for Nogales, Arizona.

The President's Corner

"In 1915, Rotary adopted a code of ethics and began printing it on pocket-sized cards. As members began to carry and read this code, they began to believe it. Thus a Rotary trend developed which, I think, played a major part in changing "Let the buyer beware" to "The customer is always right."

The years since 2008 have been very difficult for many of our members, some of whom are no















longer able to participate in Rotary. In many ways, times are not so different from the Great Depression when so many Americans faced terrible financial challenges. Like so many others in the midst of such financial and ethically difficult times, Herbert J. Taylor, a member of the Rotary Club of Chicago, was the owner of Club Aluminum and on the verge of bankruptcy. His working capital was gone and his competitors were ruthless. In an effort to save his company and his employees' jobs, he developed a set of ethical standards which he called "*The Four Way Test.*" He applied these four tests to all of his company's dealings with customers, dealers, and vendors and used these four standards to determine whether his company would work with someone. If the relationship would appear to fail any of these four tenets, he refused to do business with them, regardless of how profitable the relationship might prove to be. These four points included:

- 1. Is it the TRUTH?
- 2. Is it FAIR to all concerned?
- 3. Will it build GOODWILL and BETTER FRIENDSHIPS?
- 4. Will it be BENEFICIAL to all concerned?

These four tenets served to turn around Club Aluminum and when Herbert Taylor became the President of Rotary International in 1954, he donated the copyright of the test to Rotary. The Four Way Test has been translated into the language of more than 100 countries and serves as the basis of all that Rotarians say and do. While Rotary is focused on its philanthropic efforts, it also started as a means to help business owners to sift out who among them shared common ethics, values, and community aspirations. As we determine who we would hire or collaborate with from a business perspective, it is reassuring to know that our fellow Rotarians are those that we can hopefully trust to share our ethical standards and values.
