The Rotary Foundation's Group Study Exchange (GSE) program is a unique cultural and vocational exchange opportunity for businesspeople and professionals between the ages of 25 and 40 who are in the early stages of their careers. The program provides travel grants for teams to exchange visits in paired areas of different countries. For four to six weeks, team members experience the host country's culture and institutions, observe how their vocations are practiced abroad, develop personal and professional relationships, and exchange ideas.

Join us this week at Rotary Club of Tucson as the District 5500 Group Study Exchange team gives a brief presentation on their amazing experiences traveling through five of the eleven countries of Rotary District 2450. The team members will share their pre-departure goals and whether their expectations were met by this journey through the Middle East. March 31 Work Project for Amphi Clothing Bank

It's been awhile since the Car Show and our "helping genes" need some exercise! On March 31st, Dave Gallagher, our President-Elect-Elect, will be working on a project with the Amphi Schools Clothing Bank and is requesting Rotarian volunteers to help.

The Amphi Schools Clothing Bank is supported by the Amphi Foundation and is located just immediately south of the high school on Stone (between Yavapai and Ft. Lowell Rd.) Dave has some history with the clothing bank and has shared that they serve a great need in the community providing clothing for students. The Amphi District provides a rent-free building but provides very little if any monies for repair or upgrading.

The building that houses the Amphi Schools Clothing Bank is badly in need of painting. According to Dave, it looks more like a prison than anything else. Dave rounded up donations of paint and some painting supplies but is looking for Rotarians and their family members to wield brushes and rollers. ClubRunner is a leading provider of online Rotary software and has just announced that it is an official Rotary International Licensee. It has been working closely with Rotary International to improve productivity and communications for Rotary club and Districts globally over the past two years and this association further cements the partnership between the two entities. Benefits of being an official licensee include more flexibility in incorporating Rotary branding into the software, to further promote the organization and its clubs' public relations.

The age of technology is clearly here to stay and more than 95% of our members appear to access the Tucsotarian online. The President's Corner

Your Board of Directors meets monthly to review financials, vote on membership changes, make or revise policy, and to vote on other key club issues for which the Board is responsible. This past month the Board met for its monthly meeting on February 21st. A key agenda item this month included a review of and vote on the recommendations of the Community Charity Grants Committee.

Co-Chairs of that committee, Cindy Godwin and Mike DeVries, were invited guests of the Board meeting so that they could provide first hand explanation of the Community Charity Grants Committee's recommendations.

The Community Charity Grants Committee is responsible for evaluating and recommending where the undesignated proceeds from the annual Car Show should be donated. The Committee reviewed RCoT's long range Strategic Plan focusing on key areas relating to serving children, seniors, and other areas that may be appropriate to serve community needs. The recent recommendation of the Community Charities Grants Committee was to continue our last year's focus but to add a new area that will address the extreme jobs/workforce issues, in particular the military personnel who are returning from Iraq and Afghanistan who are not prepared for available jobs. The Board had considerable discussion about community needs as well as our ability to consider grant proposals in multiple areas. The Board voted to continue to support children and youth needs through our club's support of Reading Seed, which is now a part of Literacy Connects but to focus the grants proposal process for this year into one single new area.

To this end, the Board voted to have the Community Charity Grants Committee solicit grants from four or five selected organizations that currently provide Work Force Development for Veterans. The Community Charities Committee will review those grant proposals and select 2-3 finalists who will then present to our full RCoT membership. The members will then vote on the finalist to receive the funding alloted from the 2011 Car Show proceeds. The Grants Committee plan to get started on organizing and putting out the request for proposals soon.
