### Ethical Challenges for Challenges for Organizations in the 21st Century

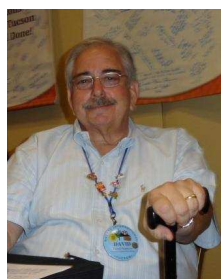

Dr. Melendez has been with the Eller College of Management since 1996. He earned his doctorate from The University of Arizona with a specialization in "privatization." ### Jesse Thorpe - Skyline Country Club

RCOT member JESSE THORPE is currently General Manager and Chief Executive of Skyline Country Club. He started as a waiter in 1982 to pay his college tuition and rent. He left in 1991 as Clubhouse Manager, moving to Milwaukee for 3-1/2 years and Las Vegas for almost 11 years before he was asked to return 6 years ago to replace another of our members, DICK KOLASA, who retired. Jesse is currently chairman of our scholarship cups.

Skyline Country Club was founded by Mr. Leonard Savage of Oklahoma City, a prominent businessman and frequent visitor to Arizona. In 1961 Mr. Savage and Mr. John Bender discussed the building of a golf course and the country club in Tucson. This discussion became a reality. The golf course opened for play in August 1962 and the main Clubhouse opened for business in June 1963.

They named the country club "Skyline" because it was located 1,000 feet above the city of Tucson at an altitude of 3,000 feet.

Today, Skyline is a member owned country club with dining rooms, banquet facilities, a full service Fitness Center, an Olympic sized swimming pool, six clay tennis courts and a par 71 golf course.

In 2006 Skyline was chosen as a "Platinum Club" by a panel of industry peers for the excellence of its facilities, services, products, staff and governance. Boasting an award winning culinary team and long time employees Skyline offers a gracious "family" atmosphere for its members' enjoyment.



### The President's Corner

*Recently I've had some requests to remind our members about the appropriate use of our club roster as well as what members are permitted to promote at our club meetings. Most of our members in our Rotary club are active in other charitable organizations in our community. As a result, there are hundreds of "favorite" charities represented by our members. **To maintain fairness and to be considerate of members' time during our meetings, our Board several years ago put into writing the policy that we've had for years that states that requests to solicit funds or volunteers from our members for other charitable organizations should be denied unless our board has specifically approved the request or if it for a Rotary-sponsored activity or project.***

for other organizations that slipped by this policy and that is my fault. Just a reminder to all, "Happy Jackson Minutes" are not intended to promote other organizations. They are intended to share positive personal events, like the birth of a baby or grandbaby, a special anniversary, or perhaps the graduation of son or daughter. These have to be arranged with the President, Sergeant of Arms, or Executive Director (Mary Laughbaum) ahead of time and will cost the member cold hard cash of \$20!

**RCoT's policy is that there will be no solicitations from the floor or podium at meetings for donations, raffles, volunteers or ticket sales for any non-Rotary function. RCoT's Board of Directors approved the following organizations to be allowed to be promoted as well as any official Rotary fundraising projects: Boy Scouts, Community Food Bank, Goodwill Industries, Salvation Army Belling Ringing, and Reading Seed. We do allow members to donate tickets to other organizations' events for members to bid on during auctions or purchase our raffle tickets for these items because the proceeds go directly to our club. The policy also further states that printed materials to promote any non-Rotary function or fundraiser cannot be placed on the tables where members have their lunches. Information regarding other charitable organization's functions/fundraisers may be placed on a side table near the entrance to the meeting for members to pick up.**

As we head into a busy political campaign season, just a reminder that political campaigning in any form is not permitted within 150 feet of any meeting of our Rotary Club of Tucson and printed materials should not be placed on member lunch tables. **Political guests may be introduced along with all other visitors during Club meetings, but they may not campaign in any way nor are members allowed to use time to campaign.** If the political guest leaves prior to or during the program, the President has discretion to fine the host, so pick your candidates carefully! Political literature may not be distributed before, during, or following a Rotary meeting.

Just a clarification of our policy on political speakers versus elected officials: if it is not an election year, the program committee may invited a sitting representative in any official position such as Congressperson, Senator, Governor, Mayor, etc. because the individual was elected to represent everyone. **However, during an election year, we must invite the final candidates for a specific office either in back to back meetings or together as a "debate". If there is a ballot proposition, representatives of both sides of the issue will be invited to present.**

Last but not least, our roster information is available to our members to assist in communicating with one another regarding Rotary business. **The information in the roster should not be given out to non-members and should not be used for solicitation of business or for other charities unless it is specifically approved by RCoT's Board of Directors.** I know that some of our newer members are not familiar with our Club policies regarding these topics and I hope that this article clarifies what is permitted and what is not.
