Future of Soccer - Future of Tucson Posted by Marian Abram on Jul 16, 2012



Greg Foster is a Managing Partner of FC Tucson and heads up FC Tucson's civic and media relationships. Greg is also on the Board for the Ft. Lowell Soccer Shootout. His vision, as well as the mission of FC Tucson, is to expand, enhance and market the benefits soccer will provide to the Tucson community in terms of community recognition, sports (spring training and eventually professional soccer) opportunities, as well as increased tourism and business revenues.

FC Tucson Events, LLC (FC Tucson) operates a men's soccer team that competes in the Premier Development League - a Major League Soccer franchise league. The Club also produces and promotes soccer events. The primary event promoted by FC Tucson is Major League Soccer preseason and the Desert Diamond Cup held in Tucson, AZ in the early spring (February-March) for the past two years - 2011 and 2012.

Is the year over already? President JONI CONDIT called the meeting to

order and received a round of applause for her last meeting. KEN LIGHT

FC Tucson is also developing a model with Major League Soccer (MLS) in New York for preseason soccer tournaments that will make Tucson the western hub for MLS preseason. These tournaments will bring up to 10 MLS teams to train in Tucson, hosting the Desert Diamond Cup, a four team tournament that attracted over 30,000 fans this past February and March, 2012, as well as encourage conventions hosting events associated with preseason professional soccer. FC Tucson anticipates the preseason training tournaments, culminating in the Desert Diamond Cup, will capture thousands of hotel room nights at local resorts and will develop a sports tourism product highlighting Tucson from late January to early March annually.

To support this model, FC Tucson has re-purposed approximately forty five percent of Kino Sports Complex from baseball to soccer. As a result, the Club is able to host youth and adult amateur soccer league games and tournaments. This includes the Fort Lowell Shootout, an event that draws over 370 youth teams each year. Access to these new fields should promote further growth of this tournament which already provides a \$3,000,000 economic impact for the community each year. FC Tucson remains further committed to establishing FC Tucson soccer camps and clinics that will serve children in southern Arizona and norther Mexico.

Rotary Fellowships Posted by Drew Vactor on Jul 16, 2012

This is the first of a four article series, originally written by Drew Vactor for eClub One in 2004, about Rotary Fellowships. This installment is about the history leading up to Rotary Fellowships.

When Paul Harris founded Rotary in 1905, he conceived of community leaders with different and varied responsibilities coming together frequently to share their views. By gathering those of different professions, the individuals, their businesses and the community benefited from the balanced discussions that took place. His stated concept was to create an intimate professional organization in which professionals could share "mutual cooperation and informal friendship such as all had once known in our villages." From that humble beginning, Rotary has grown to not only help us become more aware of our community, but of our nation and of the world. We have also become participants in the process by proclaiming the motto "Service Above Self" and learning to serve the world we used to just observe.

A key component was the fact that each member of Paul Harris' original group was from a different business, providing well rounded input. As the group grew, the members learned it was important to also include educators, key members of the government, both political and professional, clergy and those professionally involved in community service. By doing so, the organization, or club, met the original test of bringing in those who saw the community from a different viewpoint to provide excellent interaction and balanced discussion.

As Rotary continued to grow to over a million members many members began to realize that they shared more than they thought despite their different backgrounds and different approaches. Although they operated very different businesses Rotarians shared a common believe in the inherent good of their fellow men and women and ran their enterprises in an ethical fashion. Past Rotary International President (and past club president and PDG) Herbert Taylor realized this commonality of business ethics and in 1932 created the "4 Way Test of the Things We Think, Say and Do", expressing how the lives of so many in our communities are intertwined as they try to do things well for the betterment of all. It has, for many, become a concise guide to ethical behavior.
