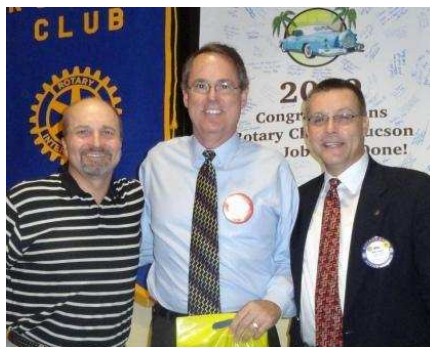

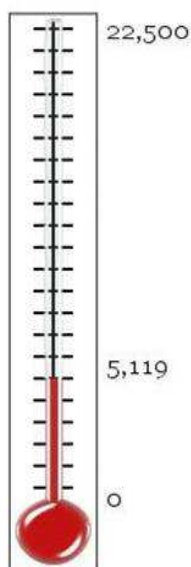

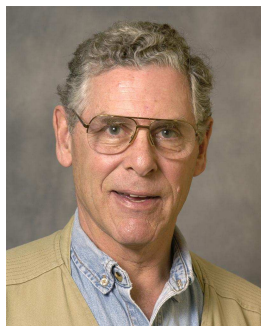

Gerry Hallowell

Don't know if you all know how interesting one of our Rowdy Table regulars truly is, so I'm going to share his life's story with you. Gerry Hallowell was born in Boston, in May of 1939. He attended Milton Academy and Harvard University. After college, he worked for Procter and Gamble from 1961 – 1968 in the Consumer Products Division followed by a variety of financial firms after that. Gerry then got a Master's Degree in Mental Health Psychology from Cambridge College in 1992. He worked in this field from 1992 through 2002, after which he retired. It was in 1995 that Gerry and his dear wife, Elinor, moved to Tucson while doing field work for his degree in mental health, stopping short of his final push for a PhD degree in this field. Gerry's concept in donating money to Rotary has been to provide scholarships to foreign students that will allow them to see our way of life, which he did. He also spent lots of time in the field that

involved physical involvement until his health began to change.

Gerry Hallowell has a long history with Rotary as a third generation Rotarian. He first joined the Minneapolis Downtown Rotary Club, in Minneapolis, Minnesota, known as "The Big One" in 1972. The rules for joining Rotary in those days were very strict and one had to be male and principal owner or second in command in order to qualify for membership. Gerry qualified for many reasons, one of them being his ownership of a livestock investment firm. When he disbanded his company, he moved to Connecticut in 1975, and took a hiatus from Rotary. In December of 2000, he joined the Rotary Club of Tucson and the rest is history.

One thing Gerry remembers fondly is the Tuesday night stories in Westwood, Massachusetts, when his father would tell about the Taunton Rotary Club, where Mr. Hallowell was a long time member. The stories were most often uproariously funny and Gerry remembers them fondly. His grandfather was also a long time member of the Taunton Rotary, with lots of good stories he shared with Gerry in his younger years.

Gerry has four children, 8 2-legged grandchildren and one 4-legged granddaughter, his Portuguese Water pup named Sandy. He is happily and luckily married to his wonderful wife, Elinor. For more stories about Gerry's life you'll have to ask him. Thank you Gerry for sharing some of it with all of us.
