Comparing & Contrasting the IRS, The Flat Income Tax and the FairTax Posted by Susan Moore Vault on Jul 12, 2013



The Fiscal cliff, sequester, the national debt, safety nets - a few of the hot issues being discussed by elected officials, lobbyists, and economists.

Does our federal tax system need to be changed or transformed?

During this presentation you will hear an objective review of the IRS and two competing tax proposals being promoted.

The current system, our progressive income tax, will be reviewed. Its history will be summarized as well as its

original purpose. Attempts to improve the current tax system will be highlighted.

The second tax system, the flat income tax, will be briefly discussed. Various flat income tax initiatives will be offered. Components of the flat income tax will be presented.

The third tax system, the FairTax, will be discussed as an alternative to the income tax system. Aspects of the FairTax that distinguish it from the current tax system and the flat income tax will be pointed out. The history of the FairTax will be summarized.

Biography

Yale Wishnick is the Director for the *Arizona FairTax for All*, a 501(c)3 nonprofit corporation.

Yale has over 30 years of experience with public and private organizations around the country. His experiences include policy development, labor relations, personnel matters, strategic planning, and individual and organizational goal setting and coaching. Dr. Wishnick has worked with community, state, and national organizations at both the macro and micro levels. He has worked with individuals, teams, and large groups to resolve conflicts, increase collaboration, and solve problems.

His academic training includes graduate degrees in Labor Education, Organization Development, and a doctorate from the University of San Francisco in Organizational Leadership.

Most recently, he directed the California Teachers Association Institute for Teaching, a think tank dedicated to improving the quality of education for all children. During his work with teachers, administrators, students, parents, and community and business leaders, Wishnick found we cannot improve our schools through traditional methods and determined the challenges facing our schools are not different from the problems we face in our economy, health care system, legal, and political framework.

Working in the schools taught Wishnick a major lesson, which he believes is fundamental, if America is to return to its greatness. *The lesson is you cannot create success by becoming an expert on what's broken and you cannot understand greatness by focusing on failure.*

Wishnick believes this key learning can be applied to our fiscal policy, specifically the IRS and federal taxes.

Dr. Wishnick is the author of numerous articles and most recently his new book, From a Culture of Dependency to a Culture of Success - Focusing on What's Right About American and the American people.

Rotary's Skiing Fellowship, Part 2 Posted by Drew Vactor on Jul 12, 2013

We recently discussed Rotary's Skiing Fellowship in the *Tucsotarian* and explained Fellowships in general, the ISFR (International Skiing Fellowship of Rotarians) specifically and the upcoming ski week at Winter Park in February, 2014. This week, let us take a look at what fellowships do in addition to the obvious function of providing a social interaction for Rotarians worldwide who have a

obvious function of providing a social interaction for Rotarians worldwide who have a common passion.

Rotary is a service organization and Fellowships often follow a service path as well. Our 2014 President Dave, has a passion for Fly Fishing and mistakenly thought the booth at the Lisboa International Convention labeled "Flying" was for him. Sadly President Dave, the International Fellowship of Flying Rotarians (IFFR) is for pilots, and they have a very important support mission. IFFR Members donate their time, funds and aircraft to supply the needy outlying areas around the world with medical, dental, optical and surgical aid in the form of material, equipment, tools, machinery, medicines time-critical fluids and transplant organs and tissue.

Similarly, ISFR members have a support mission as well, closely related to the Fellowship's main interest of skiing. Through its Davis Boyd Memorial Foundation, the ISFR raises money to support local adaptive ski programs and to provide scholarships for the training of adaptive ski instructors. In addition, members of the Skiing Fellowship often work directly with challenged skiers.

Adaptive Skiers are those who cannot ski like fully able-bodied skiers but have a desire to enjoy life and camaraderie in the great outdoors in winter. They may have a lifetime disability such as a missing or distorted limb or mental issue, a recent accident, illness or other life change such as blindness or may have been a wounded warrior. The adaptive ski programs at various resorts have expensive equipment and properly outfitted instructors to assist in helping these skiers learn to ski and/or become more proficient. Equipment may include bucket skis (for those with no legs), sit-skis or ropes and signs for blind skiers. Instructors need properly identifiable jackets and often signs to wear to explain their current purpose on the snow.

Some of the contributions have included \$3,000 during the 1999 Whistler event for the Disabled Skiers' Association of BC, \$2,500 donated to the Rotary Adaptive Ski Program at Sun Valley in 2003, the 2004 donation of \$10,500 to the Telluride Adaptive Ski Program, almost \$10,000 to the Fernie (Canada) Castle Mountain Adaptive Ski Program, \$12, 734 to the Rotary Club of Steamboat Springs for a matching STARS program (Steamboat Training Adaptive Recreational Sports), \$11,500 to The Rotary Club of Girdwood for Challenge Alaska, and \$17,173 to Whistler in 2008. Similar contributions were made to Crested Butte (Summer and Winter Programs) in 2009, Park City 2010, Aspen 2011, Revelstoke (Canada) 2012 and Telluride 2013. In some cases, the donation has resulted in the startup of a local supporting organization. In most cases, about half the money raised was retained for a self-perpetuating fund in the foundation to provide matching grants and other additional future benefits.

Many of the recipients of this largesse have gone on to win medals at special competitive events. It is amazing to see them on the mountains, many times skiing better than those raising money on their behalf, but in a sit ski or a bucket ski.

The money is raised in various ways including a silent auction as each attendee brings something from their home area, competitive events including most recently a "Peak to Valley" challenge in which donations are solicited from others for a minimum number of feet of vertical skiing and the always popular auction of desserts made by local Rotarians at the Farewell Gala Dinner. Everyone gets dessert but some, especially the chocolate ones, are just more popular -- and more expensive -- than others.

No matter whether we are doing sea level skiing at Alyeska near Anchorage, skiing at 22 below zero in Aspen, trying to speak Canadian up north, skiing the high peaks of the *Fourteeners* in Colorado or the famous Champagne Powder of Utah, we always have a great time with fellow Rotarians from around the world.
