"The District - What's New Downtown"

Fletcher McCusker is going to discuss Rio Nuevo and what is going on downtown. This will include the settlement with the City, the plans for the TCC Arena, the announcement of the new AC Hotel downtown that the District is going to be doing and a slew of other positive notes in that area.

Fletcher McCusker - Biography

Fletcher is a third generation Tucsonan, his grandfather Russell moved to Tucson from Indiana just after the depression. Russell worked for the WPA and laid many of the downtown and University area

sidewalks for \$1.00 a day and eventually went to work for the railroad. Fletcher's mother was a Tucson High grad and Fletcher attended John B Wright, Davidson and Amphi. He completed a BS in Rehabilitation at the University of Arizona in 1974 but left Tucson for greener pastures attending graduate school at ASU. Fletcher rose through the ranks in many health care companies in Oklahoma and Arizona and while working for Columbia Healthcare in Texas in 1996 he conceived and launched the Providence Service Corporation, the first home based mental health company in America. His wife, Liz, actually suggested they base the company in Tucson and Providence was launched with \$50,000 in January 1997. Fletcher followed a familiar route with Providence: his money, family and friends, venture capital, mezzanine financing and ultimate a very successful IPO. When he exited Providence in 2012 it was a billion dollar business located in 44 states and employing over 11.000 people. During the Providence run, Fletcher became very involved with the University of Arizona and instrumental in the rebuilding of downtown Tucson. He relocated the

company headquarters to downtown Tucson in May of 2010 remodeling a block of boarded up buildings that not only became the company headquarters but opened up restaurant, residential and commercial space. He joined the Eller National board of Advisors, endowed a Chair, helped launch the Institute for Civil Discourse and was named alumni of the year in 2010. His passion for downtown was a catalyst for many and in 2012 he was appointed to the Rio Nuevo board, responsible for the State funds designated to revitalize Tucson, and elected Chairman unanimously by his fellow board members. He was instrumental in the launch of Second Saturday, a downtown street festival with food and music that quickly became a Tucson tradition. Just weeks after his announced retirement from Providence, Fletcher launched a new home based health care company called Sinfonía, also in a remodeled downtown warehouse. Half of the One East Toole warehouse has been dedicated as communal office for young entrepreneurs starting their own companies. Affiliated with the McGuire Center, the Toole Avenue Hive's first three tenants were Eller alumni whose business plans were developed while at the College. Fletcher has served on the boards of the Metro Chamber, TREO, the YMCA and St. Gregory School and is a major benefactor of downtown arts organizations such as the Fox Theatre, Rialto Theatre, Railroad Museum, Museum of Art and the Museum of Contemporary Art.

His wife Liz runs Tu Nidito Children and Family Services and his son Tyler is the Program Director for KX93.5FM in Laguna Beach, CA.

K.R. Ravindran named Rotary International President for 2015-16

K.R. Ravindran was selected as the President of Rotary International on August 13, 2013 for the 2015-16 term. Mr. Ravindran is a native of Colombo, Sri Lanka. Colombo is the largest port city in the island republic. An industrialist, Mr. Ravindran is the CEO of Printcare, PLC, a tea packaging company. He has been a Rotarian since 1974. He is the first Sri Lankan to be President of Rotary International and the tenth Asian. He and his wife live in Kelaniya, Sri Lanka.

Mr. Ravindran's service in Rotary International includes stints as a Director and as Treasurer and as a Trustee for the Rotary Foundation. He has received the Rotary Foundation Citation for Meritorious Service.

Mr. Ravindran's contributions to the well-being of his fellow Sri Lankans are laudable. During the exhaustive and lengthy civil war that plagued his country's development, Mr. Ravindran stepped up

and brokered a cease fire with northern militants so that Sri Lanka could participate in the National Immunization Days. Sri Lanka was the first Asian country to be declared Polio free. Mr. Ravindran was also instrumental in securing \$2.5 million in Rotary funding to help eradicate Polio in his native country.

After a Tsunami devastated Sri Lanka a few years back, Mr. Ravindran chaired the Schools Awakening project in Sri Lanka. The purpose of the initiative is to rebuild schools leveled by the Tsunami. To date, 20 new high quality schools have been built. These schools currently benefit over 15,000 students. He also founded and is president of the Anti-Narcotics Association of Sri Lanka.

Mr. Ravindran has set as one of his primary goals during his pending Presidency of Rotary International, the recruitment of new members. He sees the expanded utilization of social media by Rotary clubs on the local, national, and international level as the key to member growth.
