### GRANT APPLICATION

#### OVERVIEW:

Rotary Club of Haddonfield Foundation supports education and charitable projects to advance higher and vocational education, to promote health and peace, and to alleviate poverty and hunger, locally, regionally, and internationally.

#### GENERAL GUIDELINES:

Applications for grant funding this Rotary year will be due by **April 15, 2024**. *Grants must be submitted by the Deadline Date.*

Only one grant can be awarded to a non-profit organization per calendar year.

At the end of the grant period, the recipient must submit an online final report by **January 31, 2025**. A copy of the report will be sent via email in December 2024. No further grants will be accepted until the report is received.

#### ELIGIBILITY REQUIREMENTS:

The Rotary Club of Haddonfield Foundation awards grants only to charitable, non-profit organizations as defined by section 501 (c) (3) of the IRS tax code.

The Rotary Club of Haddonfield Foundation supports projects and programs that:

- Provide direct services to individuals and reflect the core mission of Rotary.
- Have measurable outcomes, a plan for documenting results, and long-term sustainability.
- Have diversified income streams and demonstrate effective financial accountability.

This form is intended to aid both the prospective applicant and the Rotary Club of Haddonfield Foundation Grants Committee in evaluating a request for financial support. The Rotary Club of Haddonfield aligns with Rotary International Rotary in that we have a shared responsibility to act on our world's most persistent issues. Therefore, the projects we support:
