In order to be eligible to receive a grant, it is necessary that this form be completed and that **a copy of your determination letter from the Internal Revenue Service granting your organization status as a 501(c)3 tax exempt organization be included** with your response. You are free to provide your answers on a separate sheet of paper.

- Please type and single-space all proposals.
- Please answer all of the questions in the order listed.
- Please use headings as provided.
- Please submit only one copy.
- Please do not include any materials other than those specifically requested at this time.
- Please do not send videotapes or DVDs.
- Please ensure all tax filings with both the Federal government and state filings are up to date. Falmouth Rotary can only award grants to organizations that are up to date and compliant with their filings.

In order to allow the Rotary Club of Falmouth Grant Committee and Board of Directors sufficient time to review and evaluate all grant requests, we require that your grant request be submitted to us **NO LATER THAN NOVEMBER 30, 2025**

1. Your 2024 FINANCIAL STATEMENTS (or most recent if a fiscal year), to include a balance sheet as well as a statement of income.
