**What are are:** The Kent Rotary Foundation is a 501(c)(3) organization established in 1983 by the Rotary Club of Kent. The Foundation is governed by a Board of seven members elected from among the membership of the Rotary Club of Kent. The Foundation is funded by proceeds of fundraisers hosted by the Rotary Club of Kent and from individual and corporate gifts.

**What we fund:** The Foundation exists to serve the charitable and educational needs of the greater community of Kent and Portage County and to promote and support the Rotary Club of Kent's charitable projects.

**The Application Process:** The Foundation funds programs and projects of 501(c)(3) organizations and other charitable groups in the following three areas: (1) Education and Literacy; (2) Alleviation of Poverty; (3) Health and Wellness.

Applicants are requested to complete the application form and have it endorsed by a member of the Rotary Club of Kent. The deadline for submitting the application and any supporting documents is the last day of the month prior to the meeting at which it is to be considered.
