CORPORATE MEMBERSHIP APPLICATION



A corporate membership in the Greeley Rotary Club provides flexibility in how organizations (including corporations, local governments, and nonprofit organizations) are able to utilize their membership privilege. The benefits include:

- Having greater community involvement and making contact with other business and community leaders.
- Growing community engagement and visibility for leaders in your organization.
- Participating in leadership and community service opportunities.
- Enhancing organizational and personal exposure with other community leaders.

Process

- Application A corporate entity or organization can become an eligible corporate member of the Greeley Rotary Club through the application process established by the Club. The application process begins with a current Club member recommending an organization and its executive designee for membership.
- Approval A Corporate Membership will be elected as outlined in Article 11 of the Club Bylaws with the exception that an entity name will be recommended along with a primary designee.
- Designees A Corporate Membership requires the primary designee to be a member of Rotary International. The primary designee shall thus be listed on the rolls of Rotary International as an official member of the Club and, as such, shall have the ability to hold office, be a board member, and vote on all Club matters.
 - The primary designee may select up to three additional persons as a floating corporate representative who may attend any Club meeting. A floating representative may, but is not required to, become a member of Rotary International. If electing not to join Rotary International, the representative will not have voting or office holding privileges, but may be the primary designee's proxy for specific voting instances.
- Changing Designee The primary designee may propose their replacement, with such individual elected to Rotary membership as outlined in the Club Bylaws. A floating representative may be changed with approval of the Club board of directors.
- Corporate Membership Dues The Corporate Membership dues rate will be set annually by the Board of Directors. (The corporate dues rate as of the adoption of this Policy is \$1,500 annually, \$250 annually for each additional floating representative, and \$500 annually if a floating representative desires to be a member of Rotary International.)
