 4. The New Member Application Form is completed & advertised to the Club in Sparks for 2 weeks.
 5. After a 10-day waiting period, the Board will take the 2nd vote.
 6. The membership committee will meet with the sponsor & the new member for orientation.
 7. The New Member is Inducted.
