**Costs of Corporate Membership:**

Club bills will be addressed to the Corporate Member and shall be the responsibility of the Corporate Member and not the responsibility of the designees. A Corporate Member's designees shall be considered as one member for all record keeping by the club, listed under the name of the Corporate Executive Designee.

**Attendance Requirements:**

50% attendance is required by Rotary International and all corporate members are required to have at least one designee at 50% of the Club's weekly meetings.

**Rotary Familiarization and Induction:**

All designees will be required to attend an informational meeting about the Rotary Club of East Hartford prior to the corporate member being inducted. The Corporate Executive designee and any willing additional designee shall be inducted into the Rotary Club of East Hartford after being approved by the Board.

**Club Participation:**

A Corporate Member may name up to four people as designees, of which one shall be designated as Corporate Executive Designee. All designees are eligible to serve on Club committees and on the Board. Only the Executive Designee is eligible to serve as a Club officer. Other designees are encouraged to pursue a personal membership if they desire to serve as a Club officer. A Corporate Member may have one vote for Club elections and voting. Unless otherwise indicated by Corporate Member, the Corporate Executive Designee shall vote on behalf of the Corporate Member.
