The classification shall describe the principal and recognized activity of the member's firm, company, or institution, the member's principal and recognized business or professional activity, or the nature of the member's community service activity.

This club's membership should represent a cross section of the businesses, professions, occupations, and civic organizations in its community, including age, gender, and ethnic diversity. We are committed to diversity, equity, and inclusion. Help make that the reality of our club's membership.

#### **Standard Procedure**

The sponsor of a prospective member initiates the proposed membership process by submitting this form to both the club president and the club secretary. The club secretary notes the date of receipt, and the club president submits the proposal to the board of directors.
