The Rotary Club of Enid strongly encourages, but does not require, attendance at Monday noon meetings. Meetings are in the Stride Center ballroom, with a buffet-style lunch catered by the Stride Center Staff.

Corporate membership dues are \$240 per quarter (\$960 per year) for the first member and **dues** are \$187.50 per quarter (\$750 per year) for each additional member. Dues **shall consist of weekly meeting meal, RI per capita dues, subscription fees to The Rotary magazine, district per capita dues, club annual dues, and any other Rotary or district per capita assessment. Dues are paid quarterly, due January 31, April 30, July 31 and October 31.** Dues must be paid by the Corporation for all members. If paying by credit card a fee will be added to your next statement.

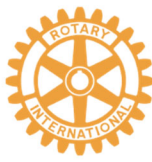
