



Dear Fellow Rotary Members,

Thank you for your consideration in your giving for Rotary this year. The enclosed charitable statement gives a breakdown of several giving options available. I would like to encourage you to consider the following items as you make your giving decisions.

1. Your **Service Fund Contribution** is the primary way we fund our own club projects. Including:

"People with Disabilities" We have worked with JP Lord school, Munroe-Meyer Institute, Mosaic, Madonna school and many more individuals and organizations funding projects like educational materials, sensory learning tools, camperships etc. to help individuals or groups with unmet needs.

Operation Hippocrates helps fund the work we do in Belize for child heart care. **Rotary Youth Leadership Academy (RYLA)**, supporting youth in leadership growth.

Many other service projects - like the recent **Human Trafficking**, and **Tree Planting** projects. **We have fallen short** of our historical donations in the last couple of years which has forced us to cut back or limit the impact we can have as a club helping in our area. I hope every member can give the \$100 requested amount as a minimum and if you are able I encourage you to consider a larger gift. We are working on several needs which would require larger funding and we are hoping for your help.

2. I hope you will consider a gift to our **Omaha Downtown Rotary Club Foundation** which funds many grants in our local area including our Rotary scholarships given out at our honor roll luncheon each year.

3. **Rotary International** donations help fund local projects through District grants which our club uses to increase the impact of our projects, and worldwide Rotary projects. As an incentive to get started in giving to Rotary international we have club members that have graciously offered **Matching Points** to be awarded to any first time contributor in our club up to the first \$100 in giving before year end. This earns you twice the credit toward reaching your first Paul Harris Fellowship.
