**Bob Harvey**, with an intro from **Mary Younggren**, crooned and painted as he reinforced and glamorized the invite to our Oct. 11 fundraising event—Rendez-vous in Paris. So romantic.

New member **Mike Ogle**, sponsored by his father in law **Thom Winninger** (did Mike have a choice?), was inducted into our Club. Welcome, Mike. We are so glad to have you be a member of the team. Remember Mike, Thom does the funny stuff in the family.

**Keith Benson** introduced our guest speaker, Greg Krauska (a Chanhassan Rotarian), a ShelterBox ambassador.

Rotary International has been actively involved with ShelterBox for years. In fact, Greg told us Rotary provides 20 percent of ShelterBox's total funding. ShelterBox is headquartered in Cornwall, England. Its mission is to deliver humanitarian relief in the form of equipment and materials that bring shelter, warmth, and dignity to individuals and families impacted by natural disasters worldwide, including earthquakes, floods, tsunamis, war, drought, etc.

The key component in the shelter box is the rugged and versatile uniquely developed ShelterBox-domed tent, modeled after an African bush hut. The tents have built-in mosquito screens, integral groundsheets, internal privacy screens, excellent ventilation, etc. Included are thermal blankets, insulated ground sheets, water purification equipment, a multi-fuel or wood stove for cooking and heating, a basic tool kit including an ax and hammer and hoehead, etc., which allows families to participate in rebuilding and sustaining their lives during the duration of the disaster. Also included are children's activity kits.

Other disaster relief organizations focus on food, water and medicine whereas ShelterBox's niche is protection and shelter and privacy from the often harsh and devastated environment. Its intent is to minimize the disasters negative impact and shorten the time before the family returns to relatively normal living conditions pre-disaster. Each ShelterBox package is customized depending on the disaster event, the location, environment, and other particulars that influence what is needed at that time.

Some key things that make ShelterBox so distinctive, effective, and meaningful are:

• Experience—responding to over 200 disasters in 90 different countries

- Training of responders—politically, militarily, medically, etc.
- Political neutrality
- Prepositioning—inventory at the ready in key geographies throughout the world.

• Quality of volunteer teams deployed and their effectiveness they assess, work with key partners and NGOs, clear customs quickly, and forward logistics to shorten the time for arrival at the disaster.

The ShelterBox concept and organization and its effectiveness is very impressive. It saves and improves people's lives in the midst of cataclysmic tragedies that only arrive once in a lifetime or less. Rotary is proud to be associated with this organization. ## **Committee Reports**:

## **Club Service:**

- The vocation meeting visit will be May 8, hosted by Paul Peterson. Registration will be very limited. Information to come.
- Working on the transition from Marty to Barbara.

## **Community Service (Projects):**

- Feed My Starving Children will be May 3. Sign ups are taking place now.
- Jeremiah House is booking months ahead and seems to have enough volunteers. The committee is looking at other organizations that may need more volunteer assistance.
- The park clean-up at Wooddale Park is scheduled for Saturday, May 17, and sometime in September.

## **Community Service (Local Grants):**

- All grants are now funded.

## International Service:


