Sutton McGraw and **Heather Hansen** were acknowledged for their efforts with the Rotary Youth Exchange. The Rotary Youth Exchange was started by a Rotary Club in Denmark in 1929. Around 9,000 students a year are sponsored by Rotary Clubs. **Jeff** and his wife, Alley, are hosting an exchange student from France named Louis and Jeff spoke about what a wonderful experience it was. Louis spoke briefly about his time in the United States and exchanged host club Rotary flags.

Jeff also acknowledged **Terry Stevens'** work for the Youth Exchange, receiving the Mayor's commendation award a few years ago. Terry was there to introduce next year's Youth Exchange outbound students, Kat and Amy, who spoke briefly about where they grew up, attended school and discussed their travel destination. We wished them well on their adventure.

Joe Hayes introduced Edina resident Roy Smalley to speak. Roy is president of the 501(c)(3) organization Pitch in for Baseball. PIFB was established in 2005 and has partnered with ESPN, USA baseball, Little League baseball, Wilson and Easton equipment, along with many others. The group provides baseball equipment to underprivileged and underserved children. Typically these children are from urban, very rural, or disaster areas. Over the years, PIFB has donated over \$3.5 million dollars in equipment and have had an impact on over 250,000 children.

Roy told a story about the impact this equipment had on children in war-torn areas and that anyone in the world could go to their website at <u>www.pitchinforbaseball.org</u> and sign up for a grant. The organization has made grants to applicants in 77 countries.

Roy talked about a meeting that PIFB had with former President George W. Bush, and how the president had been impressed with what the organization was doing.

Rotarians can help PIFB by donating money or equipment. They can also help their communities by requesting grants for children in need. The website is a great source for more information if you are interested in learning more about PIFB.

Norberto Moran thanked the speaker.

Jeff finished the meeting by thanking all of those who helped with the meeting, as well as guests, visiting Rotarians, and YE student Louis for attending. He also wished YE outbound students Kat and Amy well on their travel abroad. He closed the meeting with a quote from Robert F. Kennedy: "This world demands the qualities of youth; not a time of life, but a state of mind, a temper of will, a quality of the imagination, a predominance of courage over timidity, of the appetite for adventure over the life of ease."

Meeting adjourned.

Board of Directors Propose Changes to the Club, Foundation Bylaws

The Board of Directors recently recommended changes to the club's and Foundation's bylaws. If approved by the general membership, the two sets of bylaws will go into effect with the start of the new Rotary year on July 1.

In addition to some minor tweaks to better reflect the current operations of the club, the club's bylaws were amended to define four member types: active members, senior active members, probationary members and honorary members. Probationary members are defined in the proposed bylaws as "Rotarians who have broken one or more of the Rotary Club of Edina's policies or who have fallen behind in payments by two quarters. Unless the Board of Directors decides otherwise, a member is classified as 'Probationary' for six months after the Board determines that he or she broke a policy or until his or her account is paid in full. Any Probationary Member who breaks a Rotary Club of Edina policy or falls behind in payments by a third quarter shall be deemed to have resigned as a member of the club."

The Edina Rotary Foundation's bylaws were completely rewritten to better reflect the current operations of the Foundation and to establish an endowment. The Edina Rotary Legacy Fund will be the new endowment portion of the Edina Rotary Foundation. The principal will always be there, and the earnings will help fund the many programs our members support:

- Local/Community Service
- International Service
- Youth Development Programs
- Scholarships
- International Exchange Programs

The general membership will vote on the bylaw changes at an upcoming club meeting. Members are encouraged to review the draft documents online on the Club website,

<u>www.edinarotary.org</u>. Once logged in, go to "View Club Documents," then click on the "Board of Directors" folder, finally the documents can be found in the "Club Bylaws and Amendments" folder.

What was your first job? Airline Pilot
