### In Review

Nov. 10, 2014

On an unseasonably cold and snowy early November Monday, we were warmly greeted by **Patti Ellingson-Solheim, Mary Hustad, and Joe Graca** at the 2014 Area 3 Veterans Luncheon. The front desk was handled by **Michael Stanzak**.

We were warmly greeted by emcee Diann Kirby from Bloomington Noon Rotary, who handled the meeting this week. We started out with the Presentation of Colors by The Fort Snelling Rifle Guard and then The Pledge of Allegiance and the 4-Way Test by our own **Tim Murphy**.

This is a combined meeting of the southwest metro Rotary clubs, and is held every year around Veterans Day. The presidents of the attending clubs were introduced to all attendees:

We were also introduced to the city council members present at the meeting. Rep. **Ron Erhardt** introduced several servicewomen who were responsible in part for the state of Minnesota introducing a "Woman Veteran" license plate, one of the first in the country. We were serenaded by The Rotary Brass Quintet.

We also learned about the origin of Veterans Day: Veterans Day is an official United States holiday that honors people who have served in the U.S. Armed Forces, also known as veterans. It is a federal holiday that is observed on Nov. 11. It was once called Armistice Day to mark the anniversary of the end of World War I (major hostilities of World War I were formally ended at the 11th hour of the 11th day of the 11th month of 1918, when the Armistice with Germany went into effect). The United States also originally observed Armistice Day; it then evolved into the current Veterans Day holiday in 1954.

Introducing the program speakers were Brig. Gen. (Ret.) **Dennis Schulstad**, who pointed out the ways the National Guard works in our world today. As an all-volunteer group, the National Guard of the several states, territories, and the District of Columbia serves as part of the first-line of defense for the United States.

The keynote speakers were Major Jackie Stenger and Sgt. First Class Angela Bedesem, both of the Minnesota National Guard. They spoke of their years in the Guard and how rewarding it has been to their lives. They also talked of the personal sacrifice when they are deployed and are away for long periods of time—it is very hard on the children and spouses. In the end though, even with the hardship, they would never give up the experience of their military service.

Diann Kirby thanked the speakers for their time with us as well as their service of our country, and we were adjourned at 1:30 p.m.



## Rotary Camp Enterprise 2014

This year's Camp Enterprise, chaired by Tom Gump of the Edina Morningside Rotary Club, was the result of hard work by many Rotarians from both the Rotary Club of Edina and EMRC. John Flynn, who handled marketing and many other aspects of Camp E this year, shares details of 2014 Camp Enterprise:

- 110 students from 61 high schools attended
- 61 Rotary Clubs participated
- \$6,000 in scholarships awarded
- Close to 90 people volunteered

The students arrived on Thursday morning, Nov. 6, at YMCA Camp Ihduhapi and became great friends as they experienced the free enterprise system. The students interacted with a wide variety of keynote speakers and business professionals. And all the while, with the help of their Rotary mentor and counselor, solved a group of business problems and developed a business plan for a struggling company. They then presented their plan to a Venture Capital team. On Saturday afternoon, Nov. 8, our Venture Capital team leaders recognized the outstanding business plans, and at the conclusion of camp, six students were each awarded a \$1,000 scholarship to be used for post-secondary education (*photo at right*). It was a fantastic three days of leadership training, presentation skills development, team building, business experience, and fun. Next year Kip Peterson will chair Camp E, set for Nov. 5-7, 2015.
