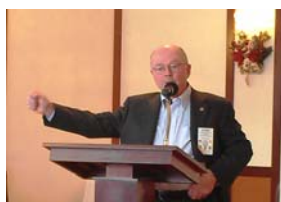

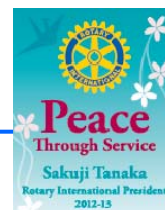

Stillwater Rotary Club Grants

AWARD CRITERIA

The Stillwater Rotary Club regularly receives requests from organizations, groups and individuals asking for financial support for a particular project, event or program. To assist our club in responding to these requests in a way that is consistent and which reflects the values and priorities of the club, general award criteria have been adopted. They include:

- Programs or projects that promote the community's health.
- Programs or projects that benefit children, youth, and families.
- Programs or projects that benefit children or adults with disabilities.
- Programs or projects that benefit elderly citizens who do not have other resources or financial, social or emotional support.
- Programs or projects that benefit areas where people are without basic levels of food, shelter or welfare and where a Rotary intervention can have a demonstrated impact.
- Programs or projects that embrace the arts in the St. Croix Valley Area.
- Programs or projects that benefit the environment and help protect natural resources.

Except in extraordinary circumstances, only requests from nonprofit organizations are considered. Requests that benefit groups of individuals or the community as a whole are given priority. Only in unique situations are grants made for an individual. In those cases, it needs to be clearly demonstrated that the grant on behalf of an individual will result in a community benefit.

Except in extraordinary circumstances, grants are in the \$100-\$500 range. Consideration is also given to making a \$25 contribution to any group or individual that provides a Rotary program and requests such a contribution. Contributions to public, governmental or educational institutions are only considered for programs or projects not funded by public tax revenues and that reflect the club's stated priorities. No contributions are made to any organization that is affiliated with a political party. Last but not least, the Rotary Four-Way Test guides the Board's response to all requests for financial assistance.

All applications are reviewed at the March board meeting and funds are distributed by April 15.
