The **Rockford Reads** project will enhance the literacy development of second grade students in all elementary schools. The direct benefit to the children will be increased exposure to print and book language through adults reading aloud and listening to the children read a book. Community Volunteers give as little as one hour per week to read one-on-one with students at an elementary site of their choice. This 2018/2019 school year is the seventeenth year that **Rockford Reads** has successfully brought together community volunteers and elementary students to work together on reading skills. Since inception, over 3,000 young people have benefited from the program.
