LAST WEEK: Dan Young, Central New York Regional Representative for Gov. Cuomo and son of former Syracuse Mayor Tom Young, spoke to us about the fiscal challenges facing New York State and local governments and school districts, and the economic development efforts underway to help create jobs in the State. Also Francis Conole, son of Club Rotarian Bill Conole, was back from his latest tour in Iraq and joined us for the evening. In addition, former Club President Cindy Scaringe (1998-1999), visiting from the State of Washington, attended our meeting and shared a few thoughts and fond memories about her time here as a Skaneateles Rotarian and former leader of our Club.

Bob Shields, a Marcellus Rotarian, also spoke to our Club about a Marcellus Rotary International "Making A Difference" Project for which their Club is seeking financial support from neighboring Rotary Clubs. The Marcellus Club has been working with the Rotary Club of Pashupati, Kathmandu, Nepal, to assist a young man named Manoj Kumar Shah achieve his goal of completing grades 11 and 12 in A-level. The total need is roughly \$250 a month or \$3,000 a year to cover the educational and living costs. Marcellus Rotary donated \$300 in 2009 and Rotary members and friends donated an additional \$2,375 through January, 2011, so Manoj's needs were covered in 2010. Two Marcellus Rotarians are contributing \$1,500 per year, but the need for the next two years requires an additional \$1,500 and, thus the Marcellus Club is reaching out to its neighboring Clubs for support.

Chuck O'Neil plans to pass the hat at this week's meeting and also address a contribution from the Club at the next Board Meeting for this inspiring project.



Mark Your Calendar: September 8th is set as the date for our Pancake Breakfast Volunteer Thank You Picnic at Lourdes Camp. An exciting change this year is that we are combining the Volunteer Thank You Picnic with our annual Rotary Youth Exchange Welcoming Picnic. This will allow many Rotarians, who do not generally attend the YE event, to share in that experience, and, in turn, it will allow the YE host parents, many of whom volunteer at the pancake breakfast, but rarely attend the Thank You picnic, to join in the fun of the Lourdes event. In addition, this year we have changed the caterer and menu. Dinosaur Bar-B-O will cater the event this year and the menu will include: pulled pork, boneless chicken breasts, salt potatoes, coleslaw, baked beans, a tomato and cucumber salad, and rolls. All Rotarians are asked to bring a hors d'oeuvre or dessert to share, as well. As was the case last year, it is a **BYOB** event again this year, although we will provide non-alcoholic drinks as in the past. This allows us to keep the total cost down (which means more money available for worthy causes), allows Rotarians to bring their drink of choice, and eliminates any licensing and liability issues or responsibilities related to serving alcohol. Weather permitting; a bonfire and sing-along starting around 8PM with plenty of marshmallows available to roast will take place by the lake. Your invitation to sign up for what promises to be a very fun evening will be e-mailed to you by the picnic committee within the next week. Lastly, for those Rotarians who would prefer not to drive down to Lourdes, we plan to set up a car pool, and if we determine there are many who wish to car pool, we plan to arrange for use of the Laker Limo. Membership Report: The Membership Committee will continue to monitor our progress toward achieving the Club's goal to improve Participation and Dinner Meeting Attendance in the current year. While we have a highly active club, if it feels that attendance is a little sparse at our dinner meetings recently you are correct. The two charts below show how we did with regard to reaching our 50% Participation goal (a combination of Thursday dinner meeting attendance and make-ups) and our 25% actual meeting attendance goal in the past year. Forty-two percent (42%) of our active members are not meeting the 50% goal, and 26% of our active members are not attending at least 1 meeting per month. You'll be hearing more from the committee about meeting our goals this year. Right now we'd like to ask: Are you participating as an active member of the Club, and are you taking full advantage of the make-up process?

Following the war, I returned to this area and after a few years worked in accounting, inventory control and production control for the Continental Can Company in Syracuse. However, after 14 years with the company, management announced they were closing the plant, but had a job waiting for me in Chicago. Eventually, we found a business (and building) for sale in Skaneateles, a business in which we had NO experience. Nevertheless, we worked pretty hard, the business became successful, and after about thirty years we were able to retire.

My wife and I have been fortunate to have visited all fifty states, and all of the continents, except for the Arctic ones during our marriage, 65 years as of the last day of this month. And even though we have seen much of the world over the years, we were never sorry we made the decision to settle in Skaneateles. Incidentally, my wife and I have attended over twenty Rotary District Conferences, one as close as the Hotel Syracuse and another as colorful as the Playboy Club in New Jersey. I will be celebrating my 50th year as a Rotarian next year. I am also a Past President of the Club. Can You Name Me?
