It is understood, that if my membership is approved, there are certain attendance, financial and civic expectations associated with that membership.

The Rotary Club of New Braunfels meetings are held every Wednesday at noon unless the membership is notified otherwise by the board of directors. Members are expected to attend no less than 50% of all weekly club meetings. If a member is unable to attend a weekly meeting, it is the responsibility of the member to make-up the missed meeting by: attending another Rotary Club meeting, through pre-approved make-up events (socials, board meetings, etc.), or via E-Club.

Financially, members are billed on a quarterly basis at the beginning of each quarter. The club follows the typical quarters of the standard calendar year. The average quarterly bill is about \$270 which covers club dues (\$65), Rotary Foundation contributions (\$25) plus meals (\$180 – based on an average of 12 meals per quarter). Should a member choose to resign; it is the responsibility of the member to notify a member of the board of directors. The earliest date of resignation that will be accepted, for billing purposes, will be the date notification of resignation is received by a member of the board of directors. Therefore, members are responsible for all billed amounts, up to their resignation date. A member's absence does not waive a meal charge. Members are charged for all meals regardless of whether or not the member eats the meal or not, unless a make-up is completed at another club.

Finally, the New Braunfels Rotary Club participates in both Wurstfest and the Comal County Fair. All members are responsible for assigned shifts at each event. If the member cannot be present to work the shifts for which they are responsible, it is the responsibility of the member to find a replacement.
