PRESIDENT'S CORNER



This week I was pondering ethical vocational service. I read an article recently (August 25, 2010) by Robert Reich, the former U.S, Secretary of Labor talking about the particularly unethical behavior of Jack DeCoster the CEO of "Wright County Egg". This person has been convicted of numerous workplace violations, including of state

environmental laws, of animal cruelty and of the mistreatment of (female) workers, According to Reich he (DeCoster) considers fines a cost of doing business and has thus flaunted local, state and federal laws. Reich goes on to point out BP has a similar record of malfeasance ignoring safety standards for years on numerous projects. I am certainly aware of BPs poor stewardship concerning Prudhoe bay. So why mention this.

You may know that Rotary has certain fairly detailed principles they expect members to abide by in relation to vocational service. This is not an easy assignment but we are called upon to set an example. Like many ethical guidelines one may conflict with another at times. In those instances I suggest consulting with professional peers. More than ever we need Rotarians to be examples of good moral character in the world of business. We should frequently examine our own motives and seek to balance our interests with those of society at large. Here they are for your review.

1) Consider my vocation to be another opportunity to serve;

2) Be faithful to the letter and to the spirit of the ethical codes of my vocation, to the laws of my country, and to the moral standards of my community:

3) Do all in my power to dignify my vocation and to promote the highest ethical standards in my chosen vocation;

4) Be fair to my employer, employees, associates, competitors, customers, the public, and all those with whom I have a business or professional relationship;

5) Recognize the honor and respect due to all occupations which are useful to society;

6) Offer my vocational talents: to provide opportunities for young people, to work for the relief of the special needs of others, and to improve the quality of life in my community;

7) Adhere to honesty in my advertising and in all representations to the public concerning my business or profession;

8) Neither seek from nor grant to a fellow Rotarian a privilege or advantage not normally accorded others in a business or professional relationship


2010-2011 Club Goals

PROGRAM

Bryan Washington, Executive Director of United Way Lincoln/Lancaster

County was our speaker. Most people know of United Way because of their annual drive but that is not all they do. This year their goal is \$5.93 million. Most contributions come from large institutions. Last year 350 companies contributed. They currently partner with Community Health Charities to



United Way is governed by a 28 member board but most of the funding decisions are made by volunteers.

Currently 42 agencies are supported by the United Way campaign. Team-Mates and the Boys & Girls Clubs were added this year. Unrestricted donations make up about 65% of funds raised are allocated by a citizens review process. Potential recipients are required to apply for funds each year. The applications are re-

> viewed by volunteers and each agency gives a presentation to the funding committee. The funds are targeted in 2 areas: 1.) Kids and 2.) People in Crisis. Applicants must have goals that meet these criteria to receive funds. Also auditors review the financial statements

of the applicants to make sure they are viable entities. Last year there were \$1.6 million in requests that could not be honored so the need is great.

United Way meets the Better Business Bureau's standards for charitable organizations which requires that less than 35% of the funds raised be used for operations. United Way only uses 14% for operations.
