



PROGRAM

Tyson James of Wastecap Nebraska was our speaker. Wastecap is a nonprofit organization committed to helping businesses and communities develop and expand their environmental stewardship programs, specializing in resource conservation. Wastecap conducts assessments to



One of the largest issues today is electronic waste generated by all of our electronic gadgets that become obsolete almost as quick as we buy them. Last year only 13% of electronic waste in the US was recycled. In Nebraska the amount was less than 1%. Packaging of all products also impacts the environment in unintended ways. Some products such as thermostats, batteries and paint containers have toxins that leak into the soil. Unused pesticides have a huge environmental impact. 4 billion of Medical sharps are disposed of each year. Phone Books produce excess waste due to their volume. The rate of purchase of cell phones exceeds the rate of collection for recycling.

Nebraska has implemented the Product Stewardship Initiative to deal with these issues. The Initiative is a cooperative effort between non-profit organizations, municipalities and the solid waste management community to build product stewardship capacity and infrastructure



Product Stewardship is a principle that directs all those involved in the life cycle of a product to take responsibility for the impact to health and the environment that result from the production, use and end-of-life management of the prod-

uct. Producers who design and sell the products gave the greatest responsibility to package the product with the environment in mind and to recycle the product once it is used. They also have the ability to make the biggest impact. They can manufacture greener products and build in the recycling cost into the cost of the product before it is even distributed. Consumers have a responsibility buy more durable products without toxins and to dispose of used products properly. Many retailers offer take back programs and recycle the product with the manufacturer.

Currently in Nebraska most collection efforts do not involve the manufacturers but just the consumers which is a good start but does not have the impact of going right to the source. Wastecap has a number of existing programs as well as a resource book which lists recycling service providers all over the state.
