Collectively we often have strong feelings about things we don't understand. Passion is almost like a proxy for understanding. As it is Independence day, I will say that in truth I have as much respect for the reasoned/thoughtful dissenters of wars as I do for those who die for our country. In retrospect it is also clear our use of Halliburton, Blackwater and other no bid contracted services did not save us money and most likely cost us greatly in good will around the world. So if you really love your country become educated about issues. Demand reasoned political debates not sound bites. Pursue a path of peace and prosperity not war. Seek to create a world where people value their lives and conditions sufficiently that they don't want to fight. Rotary helps in many ways to accomplish these ends.

Polio Fundraiser—Aaron Babcock has contributed Husker Illustrated yearbooks to be sold at \$10 apiece as a fundraiser for Polio with 100% of the proceeds going to polio eradication.

End Polio Now Event—Nicki Klein reported Lincoln is very close to its goal for raising its portion of the \$200 million Challenge Grant to Rotary International from the Bill Gates. To raise the remainder of the funds, the Lincoln Rotary Clubs have scheduled a "Strike Out Polio" event at the Salt Dogs game on August 19th. Tickets for the club section will be \$16 each with 1/2 of the proceeds going to polio eradication. The goal is to sell 243 tickets which is the capacity of the club section. There also will be opportunities to qualify to throw out the first pitch.

Our speaker for the dav was Barb Bartels, President of the Lincoln Community Foundation ("LCF"). Barb highlighted the history of the Foundation and also shared an overview of what it does.

LCF was formed in 1955 and is restricted

to giving funds only to not for profit entities. To date LCF has distributed \$60 million in grants to 100's of not for profit entities. LCF grants \$3-\$4 million per year and last year gave to 273 Not for Profits in the Lincoln/Lancaster County area. LCF also awarded 67 scholarships last year under their scholarship program.

Barb wanted to convey 3 things to the group: 1.) LCF is for everyone in the community, 2.) LCF is updating its policies to make access more user friendly and 3.) LCF is a convener in the community around certain issues. For example, as a result of a request from Admiral Mullen at the national conference, Lincoln is getting involved with programs to help military service members.

The goal of LCF is "Lincoln Forever" which is accomplished by connecting donors to needs of the community. With LCF a donor make a gift with the assurance that their wishes will be per-



manently honored. Gifts to LCF can accomplish many goals by a.) Supfuture porting needs, b.) Benefitting certain Charities or c.) Supporting a specific area of interest such as children, arts. older adults, etc.

The first gift LCF was \$500 which was used for a new projector at the Pinewood Bowl.

Funds of LCF include:

- Lincoln Forever Fund- Permanently unrestricted
- LCF Endowments including the LCF Fund, LCF Building Fund and the Foundation Garden Fund
- Donor Named Funds— Established in the family name of a donor to support specific causes. These include Donor Advised Funds and Donor Specified Funds.

There are 2 ways to give to LCF:

- 1. Give now on an annual basis. One way to accomplish this is to place funds in a Charitable Checkbook Fund which is a donor advised fund. .
- Give later with planned gifts through a will or a trust.

Some of the projects funded by LCF include, Lincoln Symphony, Lincoln bike trails, Lied Center Rose Garden, Pioneers Park and Lincoln Station.
