



#### **PROGRAM**

Nicki Klein introduced Andrea Eischen. Andrea was born and raised in Omaha, Nebraska. She attended the University of Nebraska at Omaha where she obtained a Bachelor of Science in Public Relations.

She began her career with UNO Athletics and has been part of many civic and nonprofit organizations spanning the entire state of Nebraska. She happily joined the Nebraska Organ Recovery system team in 2011 and continues to spread the word about the importance of organ, tissue and eve dona-

tion. She is actively involved in the Sarpy County Chamber of Commerce/Omaha, The Kidney Foundation, The Cystic Fibrosis Foundation, and the Greater Omaha Young Professionals organization.

Andrea's presentation was entitled "The Gift of Life...Organ, Tissue and Eye Donation."

This organization was established in 1977. It is a federally designated Organ Procurement organization that serves Nebraska and Mercy Hospital in Council Bluffs, Iowa. It is a non-profit. It is independent of all hospitals and transplant centers. They are paid through Medicare and Medicaid programs.

There are 500 Nebraskans on the wait list. Around 50 of these will die each year waiting for an organ donor. Nationally there are 115,817 waiting. All efforts in drugs and treatment are used prior to becoming an organ transplant patient.

Andrea stated that there are not enough registrants. Nebraska is low as far as registering goes.

The Organ Donor Criteria includes:

Ideal donor has sustained neurological trauma

> Must be on mechanical ventilation No age restrictions on most or

Medical rule outs include cancer and HIV. These are not viable donors. Organ recovery will happen within 24-48 hours after viability has been determined.

Andrea is energetic and enthusiastic about her efforts toward educating the public on organ donation and retrieval. Blood type is crucial to donation. Organs must be delivered adult to adult, or child to child. There are specific criteria. Registration is key to getting positive results in organ donation and retrieval.

Andrea stated that you can save up to nine lives with or-

gans of heart, lungs, kidneys, pancreas, small intestines and livers. Lungs, kidneys, and livers can be divided to save more than one person. Many items can be recovered such as eyes (cornea only), long bones of arms, heart for valves, long bones of legs, tendons from shoulders, knees and ankles, veins and fascia lata which is the skin under the thigh. There are many success stories in this program

She stated that "what we do is amazing!" There are more tissue donations than organs. To sign up for being a registered donor go to:

Andrea makes over 300 presentations per year to educate possible donors. Anyone over the age of 18 is able to be a legal and binding donor under federal law. There may be exceptions to homicide, and suicide.

She ended her presentation with common misconceptions of the donor system.
