
2015-2016 Club Goals

He had no agenda when he entered the legislature and it was very overwhelming at first since the first 10 days is when all the bills are introduced. An executive committee of the legislature assigns each senator to committees proportionally by district. He is on the sins committee which includes alcohol, firearms and gambling and is also on the Ag committee and Retirement committee. He asked to be seated by Senator Ernie Chambers since he knows

the rules better than anyone.

The main issues addressed in

the last session were 1. Death Penalty which was the most difficult, 2. Gas Tax Bill and 3. Dreamer Bill.

The Senator told us that his rationale for voting on bills included 3 things: 1. He listens to his constituents as they are in a sense the 2nd House, 2. He considers how it will affect his

friends and family and 3. He considers the spiritual aspect.

During the death penalty debate the senator talked to many clergy with results all over the board. He also talked to 4 families who had someone murdered in their family. They stressed how the death penalty drags out the process on appeals causing them to relive the murder over and over with no closure. He ultimately voted to repeal the death penalty since the constituents that he spoke to 4 to 1 wanted it repealed.
