General Qualifications – A club shall be composed of adult persons who demonstrate good character, integrity, and leadership; possess good reputation within their business, profession, and/or community; and are willing to serve in their community and/or around the world.

Active Membership – Active Members must meet the above qualifications, as well as live or work within the club’s locality or surrounding area.

Honorary Membership – People who have distinguished themselves by meritorious service in the furtherance of Rotary ideals may be elected to honorary membership.

Classification – Each active member of a Rotary club is classified in accordance with the member’s business or profession. A classification describes the principal and recognized activity of the firm with which an active member is connected or the member’s principal and recognized business or professional activity.

The club shall not elect a person to active membership from a classification if the club already has five or more members from that classification, unless the club has more than 50 members, in which case, the club may elect a person to active membership in a classification so long as it will not result in the classification making up more than 10% of the club’s active membership. Retired members require a classification but are not included in a club’s total number for each classification.

Attendance – Each Active member elected to membership must maintain at least 50% attendance and 75% attendance for Corporate group; and attend at least of 30% of the regular meetings at this club in each half of the Rotary year. Make up credit may be received by attending another club meeting 14 days before or after a regular Omaha Northwest Rotary Club meeting. Members missing four meetings in a row may be removed from the membership list unless they have contacted the Board of Directors ahead of time for an excused absence during a short period of time. Special recognition is received for 100% attendance.

Permanent Badge – A permanent badge is received after attending a club orientation meeting, maintaining at least 50% attendance for six months or 75% Corporate Group, serving as a greeter and as an invocator, giving a brief vocational talk, selecting a committee(s) to serve on, volunteer for a service project, visit another Rotary Club, and bring a new member into the club within the first year of membership.

SECTION TO BE COMPLETED BY APPLICANT

I hereby certify that I am qualified for membership both by my current/former executive position and by having a place of business or residence within the club's locality or surrounding area.

I understand that it will be my duty, if elected, to exemplify the Object of Rotary in all my daily contacts and activities, and to abide by the constitutional documents of Rotary International and the club. I agree to pay the admission fee of \$125 New Rotarian, Primary Corporate; \$50 Rejoining Rotarian, Primary Corporate; or \$60 Additional Corporate and the annual dues of \$375 Active or Primary Corporate; \$275 Additional Corporate in accordance with the bylaws of the club. Annual dues are prorated for new members at the time of admission. I hereby give permission to the club to publish my name and proposed classification to its membership.
