ALL PARTICIPANTS & EXHIBITORS PLEASE READ AND SIGN BELOW

- <u>DEADLINE FOR APPLICATION IS MAY 1, 2018</u> contracts received (postmarked or electronically received) after this date are subject to higher booth space fees. Contacts received without appropriate full payment will <u>not</u> be honored. <u>Discounts</u> apply to contracts with payments received **on or before** the above noted DEADLINE
- 2. Illegible or incomplete both space contracts will not be honored (at the Event Manager's discretion)
- 3. Booth space fees are non-refundable fees do not include tables, chairs or canopies unless UPPER END SPONSOR
- 4. Spaces are preassigned upon receipt of signed contract and payment. Space numbers are given out the morning of event at check-in and not before no exceptions
- 5. ALL participants <u>must</u> have a canopy covering there are no exceptions to this rule <u>please do not ask!</u>
- 6. **CANOPY set up is NOT included** in your contract <u>unless upper-end sponsor level</u>. However, you may choose to have your canopy set up by volunteers for a \$10 fee, paid in advance with signed contract
- 7. The exhibitor agrees to secure all corners of their canopy (gallon water jugs tied to corner legs work well) Main Street tends to be breezy/windy in June. Damage occurring from unsecured canopies is the responsibility of the exhibitor
- 8. Vehicles are permitted at your space for set up and break down only (unless self-contained food truck)
- Free parking for dealers at several public parking lots will be available during the show
- 10. RAIN DATE: Sunday June 3rd; Decision made by noon Friday, June 1st . NOTE: IT MUST BE A DELUGE WITH THUNDER/ LIGHTENING FORCASTED FOR IN ORDER FOR RAIN DATE TO BE IN EFFECT. - 11. The exhibitor agrees not to sell any food or beverages unless they are a food vendor in the Food Court and have been preapproved by the Lansdale Day Event Manager in advance with signed contract, payment fees and certificate of insurance
