- DEADLINE FOR APPLICATION IS APRIL 1, 2024 This page must be signed and returned with completed Page 1 of this booth space contract. If any page is missing; contract is void. Lower price for booth space applies if payment and form is received by deadline noted on Page 1. Illegible or incomplete booth space contracts will not be honored
- THERE IS NO RAIN DATE for LANSDALE DAY The event takes place rain or shine; this is an outdoor event
- **Booth space fees are non-refundable** fees do <u>not</u> include tables, chairs or canopies <u>unless</u> UPPER END (Presenting or Corporate) SPONSOR. Activity Sponsorship includes table & chairs. Event Sponsorship level includes premiere space only.
- Electric enabled spaces are strictly reserved for certain pre-approved FOOD VENDORS <u>only</u>. We do not offer electricity to any other vendor. Generators are permitted by FOOD VENDORS <u>only</u> Please bring all devices fully charged for the day and a battery back-up. <u>There are no charging stations.</u>
- ALL participants <u>must have a 10x10 canopy covering each rented space</u> (food trucks & food trailers with awnings are the only exception) Your canopy set up is <u>not</u> included in your contract <u>unless upper-end Presenting or Corporate sponsor level</u>
- The exhibitor agrees to secure all corners of their canopy legs with weights. Damage occurring from unsecured canopies is the sole responsibility of the exhibitor. Canopy legs must fit in your 10x10 space; no slanted legs allowed
- Table coverings are required by <u>all</u> **NO BARE TABLES ALLOWED** Tables must be draped or skirted <u>top to bottom; all</u> <u>supplies, boxes and personal items hidden from view.</u> A balanced, artful, clean & neat booth space will attract customers
- Vehicle(s) permitted at your space for unloading and break down <u>only</u> (unless self-contained food truck) All non-food truck motor vehicles must be moved immediately upon <u>unloading</u>
- *** Exhibitor agrees to MOVE & PARK their vehicle(s) **<u>BEFORE</u> SETTING UP THEIR BOOTH SPACE*****
- Free parking for one vehicle per vendor at a designated reserved lot will be available during the event; a one-day-one-vehicle parking permit is included in your contract. Parking Permit issued at check-in. <u>More than one vehicle can check in with you, but only one vehicle per vendor will be issued a parking permit.</u> Any other help you bring will need to find street parking elsewhere. Additional vehicles are NOT permitted to park in the vendor lot. Unpermitted vehicles in the vendor-only lot are subject to towing at owner's expense. There is a public lot located on Vine Street - one block from the event.
- The exhibitor agrees not to sell (or give away) any food or beverages unless they are a pre-approved food vendor.
- <u>The sale or consumption of open-container alcoholic beverages during this event is strictly prohibited and monitored</u> by the Lansdale Police Department
- The exhibitor agrees that the rental space will be left clean, free of debris and/or trash
- The exhibitor agrees to not breakdown before 4pm (not 3:30, not 3:45, but 4pm)
- Returned check fees : A \$50 fee will be assessed on all checks returned for insufficient funds
- Space number assignments will be emailed to you 7-14 days before the event; along with arrival instructions & a map of the event. All participants must adhere to very specific arrival instruction, including pre-assigned arrival time
