

## VENDOR SAFETY AGREEMENT – LANSDALE DAY 2021

Dear Lansdale Day 2021 Participant,

**PLEASE READ:** With your approval to participate in Lansdale Day 2021 comes some stipulations that we and all of our vendors, volunteers and staff must adhere to in order to provide a safe environment for everyone who attends the event this year.

**Kindly note the following with regard to safety measures for Lansdale Day 2021**  
**YOUR SIGNATURE IS REQUIRED ON PAGE 2:**

1. At check in, every vendor (including the help you bring for setting up and staffing your booth space) will be asked a series of questions regarding your current health and any exposure to Covid-19. You will be asked to sign a waiver attesting to your answers. Additionally, your temperature will be taken (via temporal scan thermometer) and this will be recorded on the waiver as well. Any vendor who refuses to comply with these necessary safety procedures will not be permitted into the event and no refund will be given.
2. The series of questions you will be asked include:
  - a. Have you traveled outside of the U.S. in the month prior to the event?
  - b. Have you or anyone in your household been exposed to Covid-19 in the 10 days preceding Lansdale Day? or Tested Positive for Covid-19?
  - c. Are you currently (on the date of the event) experiencing any symptoms (ie: cough, fever, shortness of breath, loss of taste/smell) ?
  - d. Have you traveled to any state in the U.S. in the last 10 days that requires or prohibits the return to PA without first self-quarantining?

**NOTE:** anyone answering YES to any of the above questions at check-in, or who exhibits a temperature greater than 99° will **not be permitted to enter the event** and *refunds will not be given.*

3. Every vendor will be required to have hand sanitizer at their booth space for customers to use. This is NOT provided by the event host so plan accordingly.
4. Every vendor, staff and volunteer, as well as the general public will be required to wear a face mask (covering both nose and mouth) while at Lansdale Day. Anyone who is not compliant with this rule will be asked to leave and not be readmitted to the event.
5. We are asking our vendors to limit the number of customers within your booth space to 2 at a time and each customer should not browse longer than 10-15 minutes.
6. We are asking food vendors to keep an eye on the patrons in line and ask them to observe social distancing while waiting in line to be served.

We will, as always, have on-duty police officers from the Lansdale Police Department attending Lansdale Day and we thank them for their service! The Rotary Club of North Penn will be making constant announcements via the public address system, reminding everyone who attends to wear a mask and observe social distancing.
