## PROGRAM - Jeff Hughes & Greg Walker, Wentworth-Douglass Hospital

Jeff Hughes, V.P. of Operations and Chief Strategy officer gave an overview of Wentworth-Douglass Hospital's affiliation with Mass General and the current state of healthcare. Hospitals operate in a very challenging environment with spiraling costs for technology, equipment and prescription drugs. Medicare does not cover the full cost of providing care for patients and hospitals must operate efficiently and still provide quality healthcare for their patients.

Wentworth-Douglass is proud to be a community hospital serving the area and has sought to form partnerships that can better serve the community. The proposed alliance with Exeter Hospital and the merger with Mass General has been designed to offer a cost-effective approach through collaboration and leverage of purchasing power. The proposal is to create a new entity named NEWCO which would be governed by a board made up of 80% local board members and 20% representation from Mass General.

Benefits would include expanded programs and services, a team approach to such services as Cancer Treatment, Cardio-Vascular Services, Women's Health Care, and other specialties. Savings, including the recently implemented MGH record's management system Safecare, would result in more efficient sharing of health information and coordinated care.

Better pricing can be obtained due to the combined purchasing power of the entities. This has resulted in a \$4.5 million dollar cost savings for prescription drugs. The savings alone for the recent health records system was estimated to be \$15 million.

Further, the hospital has found that they have been able to retain specialists because they are now also affiliated with Mass General Hospital and duplication of effort in emergency care is avoided through collaborations.

In part because of the merger, Wentworth Douglass has been able to provide \$38 million in charity care and has supported local charities this past year with \$4.7 million in community giving.

Greg Walker, CEO of Wentworth Douglass Hospital provided an update on the efforts to merge with Exeter Hospital. The Attorney General has held up approval of the merger citing the potential for unfair competition. Walker believes this would not be the case and substantial benefits exist for the local population if the merger were allowed. Many of the arguments set forth by AG's office are no longer valid given the recent proposed merger of Frisbie Memorial Hospital with HCA Hospital Corporation.

Surveys found that the local population favors the merger by an 8-1 margin and they are continuing their efforts to press their case with the Attorney General's Office. Once it is approved at that level, there is still a yearlong process to get it approved by the Federal Trade Commission.

The good news is that a dialogue will begin again in February to try to resolve the concerns expressed by the AG's office. Support for the merger can be expressed through the website at <u>www.seacoasthealthcareinitiative.org</u>.

Greg closed by stating that this merger would be good for the seacoast community and deserves support. He answered several questions following his presentation.
