Human Trafficking is modern day slavery

Slavery is slavery, no matter what form it takes.

Trafficking belongs on the same spectrum of violence as sexual, domestic, and other violence.

Human trafficking is when people are recruited or harbored, by force, threat of force, or coercion or exploitation

It generally involves the most vulnerable of individuals who are exploited at the most basic level of humanity – their freedom

Human trafficking does not require transporting or moving the victim



It is estimated that 83% of trafficking victims in the United States are US citizens.


Most victims who are foreign born come into the US legally, on various visas.




While it is difficult to capture an accurate number of individuals being trafficking in the US annually, it is estimated that hundreds of thousands of victims are being trafficked in the commercial sex trade OR in hospitality, beauty, labor or agricultural industries

Trafficking is one of the fastest growing criminal enterprises, yielding billions of dollars annually



Labor Exploitation

> 90% experienced 8+ form of victimization 94% aware they were bein abused

San Diego Study (2016)

 Victims: as many as 11,773 sex trafficking victims per year in SD County

Industry largely run by gangs

- \$810 million in annual revenue for "pimps"
 - → \$536,000 per year
 - → \$ 45,000 per month





Our Children – USA's children -- being bought and sold for sex every day in America

Children are "owned" by traffickers – human ATMs





Child Victim Profile



- Age of entry: between 12 and 14
- Urban, suburban & rural youth
- Previously victims of abuse and/or domestic violence
- Runaways with street smarts
- Strong psychological bond with exploiter
- Indoctrinated with mistrust
- Many don't see themselves as victims (at first)







98% of victims come from California

» WHAT WE ARE SEEING

- » More CSEC from out of town.
- » Many AC CSEC are reportedly brought to LA & LV
 - » More CSEC in neighborhoods rather than main streets
 - » Online "advertising" has increased
 - » Increase in Crystal Meth
 - » More Gang involvement
 - » Increase in violence against CSEC and Sex
 Workers



WHAT WE ARE SEEING A "Snapshot"

- » From 10/2/20 to 10/3/20 over a 24-hour period there were 1,165 ads posted in Oakland with 750 profiles (750 different females).
- » From 10/4/19 to 10/5/19 over a 24-hour period there were 999 ads posted in Oakland and 666 profiles.
- » This information shows that there has been a 16.6% increase in online ads from last year and a 12.6% increase of persons posting these ads



Contributing Factors

Early childhood sexual abuse and neglect

- Lack of collaborative & comprehensive response by:
 - > community
 - government agencies
 - non-government agencies



Human Trafficking: the bigger picture

- Lack of shared information between professionals and communities affects the outcome for victims
- Perhaps inadvertently, victim/survivors are arrested while the exploiters and the purchasers are not (in violation of most states' laws)
- Traffickers are mobile and exist in shadows

Who's Luring Teens?

- Intra-familial members eg: mom, dad, step-dad, family "friend"
- Extra-familial members
 eg: pimps, sex traffickers, pornographers, madams
- Peer recruiter (other youth used or coerced by pimps)
 eg: scouts, prostituted girls
- Gang members




Effective Response to Sex Trafficking Particularly children

Must be collaborative and comprehensive

ACDAO will work to prevent the sexual exploitation of minors through training, outreach and education, and treatment of purchasers.




