# Rotary Club of Castro Valley Meeting Highlights - September 5, 2017

## Michael P. Mahoney, Chief Executive Officer of the Eden Health District



Michael Mahoney took over as the CEO of the Eden Health District on July 1, 2017. During his presentation, he discussed the evolving history of the District from its inception to present, and the direction for the future.

The Eden Health District is a government entity under the Local Health Care District Law of the State of California. The district comprises the communities of Castro Valley, Hayward, San Leandro, and the unincorporated areas of Ashland, Cherryland and Fairview. The District was established in 1948 to build and operate Eden Hospital. The Community Hospital, known as the Eden Township Hospital opened its doors on November 15, 1954.

In 1976, the District Board voted to discontinue the collection of property taxes to support the hospital. In 1997, residents of the District voted to approve the hospital's affiliation with Sutter Health, creating a unique partnership between the two organizations. In 1998, Eden Medical Center became a private, not-for-profit hospital. At that time, the Board embraced two areas of responsibility: to improve the health of

the people in the community by investing resources in health and wellness programs; and oversight and management of Community Health Fund, which is the District's grants program.

In 2004, the District purchased San Leandro Hospital and leased the hospital to Eden Medical Center to operate, under a consolidated license, as an extension of the Castro Valley campus. The District's ownership of San Leandro Hospital was transferred to Sutter Health in 2012. Sutter Health then transferred its ownership in San Leandro Hospital to Alameda Health Systems in 2013. In 2007, the District and Sutter Health reached an agreement to pave way for a new hospital in



Castro Valley, to replace the original Eden Hospital and meet the state's stringent earthquake standards. The new Eden Medical Center opened in 2012.

The Eden Health District has taken a leadership role in regional healthcare planning to ensure that the residents of the District continue to have access to quality medical services. One focus of the District is to oversee the endowment fund known as the Community Health Fund. Through responsible investments, the fund has grown every year, enabling local organizations to provide much needed health care service to those in need. Members of the Board carefully evaluate every application and make their




grant selections in open session, during a regularly scheduled board meeting. In August 2016, the Board of Directors adopted a revised strategic plan for the next five years for Eden Health District (the plan is available at <a href="http://ethd.org/wp-content/uploads/2016/08/ETHD-Strategic-Plan-2016.pdf">http://ethd.org/wp-content/uploads/2016/08/ETHD-Strategic-Plan-2016.pdf</a>).
