THE PROGRAM

BILL JOHNSON, Palo Alto Weekly, as newspapers die, what becomes of journalism & democracy?

DARRYL SAVAGE noted that today's featured speaker was a Club Member with a long and distinguished list of credentials and



achievements, very much making him a Renaissance Man. BILL smiled as he thanked her for that warm introduction.

At the outset he mentioned a talk he had given about three years ago in which he foresaw the decline of print media over several years. Particularly for national media, that decline has accelerated, due to various economic and social factors. Business advertising expenditures for print

media have declined sharply. Business now spends more on Internet organizations, primarily Google and Facebook. Local media, however, such as the Palo Alto Weekly he publishes, are doing better financially than national ones. How long the locals' good fortunes will continue seems quite uncertain. Whether experimental financial alternatives to advertising such as charging for access to on-line versions of national print media will enable them to survive also is fraught with uncertainty. Public trust in print media has declined significantly. Fewer and fewer individuals rely on print media for news. The once very widely held view that the media's most important role is to protect democracy has fallen by the wayside. A recent poll shows only 42% believe the media support and defend democracy. An equal percentage believes the media oppose or harm democracy.

In a lively Q&A session BILL expanded on his remarks and addressed questions and comments from the audience.

The meeting adjourned shortly after 1:30.
