PALO ALTO CHARITABLE GRANTS: The following are recommendations from the Grants Committee for fiscal year 2018. I'm sure we can all agree these funds will provide positive growth and support for the recipients. Kudos to the Grants Committee for turning the funds raised into grants creating actionable program support.

Fund-A-Need: \$10,000 to Project WeHope to purchase commercial equipment and supplies to support their evening meal service for their clients needing temporary housing assistance.

Ada's Café: \$5,000 for general support of their employment opportunities for developmentally disabled through the café and catering services. All Students Matter: \$10,000 to design and test a literacy intervention

program for 3rd to 5th graders reading below grade level at Ravenswood City School District.

Dream Catchers: \$5,000 to support implementation of a new system for coordinating, monitoring and communicating with parents of low income Palo Alto school district middle school students receiving support and mentoring.

EPA Kids Foundation: \$10,000 to fund mini-grants to educators in Ravenswood School District to purchase supplies and necessary classroom materials.

Nuestra Casa: \$6,000 to support a new ESL Conversation Workshop for parents of students in Ravenswood City School District to assist with developing English language skills.

Silicon Valley Urban Debate League: \$9,000 supporting students from East Palo Alto attending Urban Debate League's Summer Institute, a debate camp for low income high school students of color.

Youth Community Service: \$5,000 to support two, seven-week sessions of Ravenswood Leadership Academy a collaboration between Nuestra Casa and their middle school children with weekly opportunities providing support in developing better communication and leadership skills.

GUEST SPEAKER: The topic "Public Defense 101:" was provided by our speaker Molly O'Neal, Public Defender for Santa Clara County. She was introduced by DAVE THORTON and began her presentation by reporting she is a granddaughter of a Rotarian. Having earned an earned a Juris Doctorate degree from the University of San Francisco, School of Law
