

Our speaker, LaDoris Hazzard Cordell, was introduced by Jackie Wheeler. A graduate of Antioch College and Stanford Law School, she was the first female African-American judge

in Northern California. Her memoir, <u>Her Honor: My Life on the Bench... What Works, What's Broken, and How to Change It,</u> was published by Celadon Books in 2021.

Among Judge Cordell's recommendations for fixing things that are broken in our legal system: Law schools should offer clinical training on how to be a judge, anticipating that more than a few law students may someday be called to bench....Elections to choose judges should be replaced by independent nominating commissions.... Steps must be taken to ensure transparency when judges are investigated and disciplined.... Initiatives to recall sitting judges should be permitted only to address defined forms of misconduct.... State funds should be made available to provide meaningful compensation for time spent by jurors.... We should mandate jury

trials for felony prosecution of juveniles.... We should abolish the "felony murder" rule, whereby defendants who are not themselves murderers can be prosecuted for murders committed by other participants in their crimes... We should abolish the sentence of life without parole for juveniles.... Ways must be found to uncover and eliminate racial bias in peremptory challenges of prospective jurors.... We should reform coercive practices in the plea bargaining process.
