TODAY'S PROGRAM

PATTY McGUIGAN took pleasure in introducing her friend and speaker **Chop Keenan**, Owner of the Keenan Land

Company and prominent local citizen. Pattv explained their common interests. Chop's talk was titled "Current status and the future of Palo Alto Commercial Real Estate." His primary point was that the vitality of commercial real estate was dependent on the



presence of office workers. He reviewed the various inflection points affecting downtown Palo Alto over the years. It was started by the building of the Stanford Shopping Center and Town and Country in 1956. Then in 1965 the City Hall and 525 University was built and occupied bringing significant payroll to the downtown area. There was also the influence of the Palo Alto Clinic being there. The lifting of the Stanford liquor ban in 1971 was another positive development. In the '80s law, accounting and venture capital firms added to the numbers. However, when COVID and the move to remote work hit, commercial tenant demand plummeted and crushed retail. This negative trend is continuing. Stanford Research Park vacancy is standing at 35%. Nevertheless, with our good weather and positive presence of Stanford University, the speaker was still optimistic for the future. He saw good news in the electrification of Caltrain but was not an enthusiastic supporter of bicycles on El Camino, high hotel taxes nor closing streets.
