The Rotary Clubs of Castle Rock and Castle Pines will conduct the annual Ducky Derby on **Saturday, June 9, 2018**. The event will be held in the newly renovated Festival Park in downtown Castle Rock between Perry and Wilcox near Second Street.

The event will include a street festival which will operate between 11:00 a.m. and 5:00 p.m. Marketing entity set up shall occur between 8:30 a.m. to 10:00 a.m. Marketing entity take down shall occur between 5:00 p.m. and 6:00 p.m. The Rotary Clubs of Castle Rock and Castle Pines agree to provide booth space to the above named entity according to the terms of this agreement.

Marketing entities are required to provide their own facilities, materials and equipment, including but not limited to tents, awnings, tables, stands, signage and marketing materials. Marketing Entities shall provide their own power or heat sources. The marketing entity is responsible for ensuring that all awnings, tents, and stands are secured with sufficient weights to prevent said materials from being blown away by strong wind.

All products, displays, activities, signage and personal conduct of marketing entities must be compatible with a family environment including the presence of small children. The Rotary Clubs reserve the right to terminate any activity which does not meet this standard.

Each marketing entity shall be responsible for any sales or other taxes associated with their operation during the Ducky Derby.

The undersigned marketing entity certifies that he/she/it has or will have secured any licenses or permits required for its proposed activity. Marketing entity further hereby agrees to hold harmless and indemnify the Rotary Clubs of Castle Rock for any damages, including attorneys' fees and costs, incurred in defense, settlement or satisfaction of any claim arising from the said entity's participation in this event.

Marketing entities shall pay a fee for space at the Ducky Derby of \$150.00* (\$75.00 for non-profit organizations). This fee shall be payable in advance and the street space will not be deemed reserved until payment is received. Additional fees may be charged for spaces requiring an excess of 15 linear feet of frontage space.
