### **REPORT OF LAST MEETING - 4 December 2012**

President Kay opened the meeting and introduced Greg Cuthbert as meeting chair. There was one visiting Rotaran, John Sealley from the Portland Rotary Club, and members' guests included Diana Newcombe from Perth (a guest of John Ilott) and our guest speaker, Stephen Mayne.

Announcements were from 1. Neville Taylor – the Club Administration Committee had visited the Rotary Club of Port Melbourne as part of our Cluster Visit Program; 2. Mik Wells – the Silk Miller Scholar for the year is Senior Constable Eric Paccey and two candidates are currently at the RYLA Camp until the weekend; 3. Robin Stevens – Christmas Hampers are to be brought in t o 18 December meeting as arrangements have been made for the two recipient organizations to pick up the hampers on that day; 4. Tony Thomas – following his visit to the New Zealand holiday batch of David Jones, Tony donated a dictionary to him for the purposes of settling disputes during scrabble games; and 5. Kevin Love – on his recent visit to his Cluster Club, Kevin recommended a fundraising project that supports a Cambodian orphanage.

Our guest speaker was Stephen Mayne, Director of the Shareholders Association and shareholder activist extraordinaire. Stephen began by reflecting on the recent AGM reporting season with over 50 meetings in Perth on one day in November. Overall there have been over 1500 AGMs over the last several months in Australia. This year has been remarkable for the biggest pay cuts in Directors' salaries seen for many years which has resulted from changes in legislation, mainly through the 'three strike' minority shareholder vote being implemented.

The effectiveness of this legislation has resulted in 108 companies receiving a "first strike" shareholder rejection of the Directors' remuneration packages. Although many company boards have had votes recorded against them because of the huge salary payouts and bad performance, nevertheless these companies still paid out large bonuses.

In describing the work of the Australian Shareholders Association, Stephen outlined the need for public funding of the ASA which, by comparison the Australian Institute of Company Directors, is hugely under-resourced and therefore at a disadvantaged. One aspect that Stephen highlighted was the tendency for directors to avoid answering questions and their preference for any likely questions to tabled before AGMs. He cited an example at the recent Fairfax AGM when there was a three-and-a-half hour "slugfest" where the chairman would not let others speak, was very dismissive of questions and looked likely to be voted down on the remuneration package. However, when Stephen advised that he held 2.2 million proxy votes on behalf of the ASA and offered to vote in favor of the package if they accepted a reduction in the directors' salaries, this was agreed to and carried.

Stephen gave several examples of the need for reforms in a number of financial and governance areas and made the point that there are a number of company boards whose membership needs to be renewed as too many boards have members who hold multiple positions as directors and are practically unable to give the time and attention necessary to fulfill their duties ... finally, the power of the shareholders is wielded.
