An *inspirational* journey – from open heart surgery to around the world cyclist

Jeremy recently completed a solo, self funded, 52,000km bicycle ride from London to New Zealand that took him through 29 countries and over 2½ years to complete. There were moments where he genuinely feared for his life while on many other occasions he experienced the beautiful side of humanity. His numerous stories from

the road will leave you amazed and inspired while the images he shows are simply breathtaking.

As a toddler Jeremy could not run around a field with his friends and required major open heart surgery as a four year old. Thirty four years after this life-changing procedure, Jeremy knew he had been given a second chance in life and craved a challenge that would test him both physically and mentally to the absolute limits of his being. With practically no experience or training he set off on this incredible journey around the world on his bicycle.

From London through Europe, Turkey, Iran, Central Asia, The Far East, South East Asia then Australasia, Jeremy confronted mother nature at her worst while also experiencing the good and bad sides of human nature. Jeremy's story is a beautiful example of what people can achieve if they believe in themselves and have the courage to chase their dreams.

He is currently Chairman of Qantas Airways Ltd, a role he has held since 2007. He is also a Director of Bechtel Group Inc. and Chairman of Bechtel Australia Pty Ltd, the Murdoch Childrens Research Institute and the National Gallery of Victoria Foundation. He is a senior adviser to Kohlberg Kravis Roberts & Co and a Member of the Council of Trustees of the National Gallery of Victoria.

Between 2000 and 2007, Mr Clifford was Chief Executive of Rio Rinto. His executive and board career with Rio Tinto spanned 37 years throughout many of the company's divisions in Australia and overseas.

Guest Speaker – Dr James Barry



James is an Associate Research Fellow at Deakin University and an expert on the Middle East and Islamic State's sectarian agenda.

Islamic State (IS) is essentially a Sunni movement opposed to the Shia sect. It arose out of Al Qaeda, an organisation it now sees as the opposition. IS seeks to establish a Caliphate in Iraq and Syria. This is a highly controversial aspiration and is not supported by most Islamic movements.

IS does not like France in particular as France refuses to call the movement IS or ISAL in deference to the diverse ethnic Muslim population of France. This position has infuriated IS. Also, IS seeks to penalise France for its intervention in its former West African colonies where

there is a major Muslim population.
