Leg amputees were assisted by the 'C-Leg' manufactured by Otto Bock at the cost of \$7 (about 10 times average annual wages at the time). Ankle and knee sensors send mes for speed and acceleration through a microprocessor. There are also two hydraulic circ and flexion. The robotic arm has now been developed with up to 25 joint motions while arm has 30 joint motions. It has come to the stage that the wearer only needs to think v wants to do and the prosthetic arm will act accordingly. The cost of these arms at prese million.
